The application u/s 483 of B.N.S.S. filed on behalf of the petitioner/accused, namely 1. Madheb Karenga and 2. Bisweswar Karenga in connection with Chhatna PS Case No. 54 / 2026 dtd. 18.05.2026 u/s. 329(3) / 115(2) / 118(2) / 109 / 74 / 79 / / 351(3) / 3(5) BNS is taken up for hearing.

TCR is received. C.D. is also produced.

Ld. Advocate for the petitioners submitted that he does not want to press the bail petition in respect of **petitioner no. 2 namely, Bisweswar Karenga**. Ld. Advocate endorsed '**not pressed**' on the petition. The bail petition is accordingly disposed of.

Heard the Ld. Lawyer for the petitioner/accused namely Madheb Karenga.

Heard the Ld. Public Prosecutor.

Ld. Advocate for the petitioner/accused has submitted that no bail petition is pending before the Hon'ble High Court, Calcutta.

An affidavit has been filed on behalf of the petitioner/accused swearing that no application u/s 482 of the BNSS has been filed before the Hon'ble Court.

It is found upon perusal of the affidavit, duly furnished on behalf of the petitioner/accused, that no case is pending before the Hon'ble High Court in connection with the present case.

Accused/petitioner by filing a petition submit that they have falsely been implicated in this case.

He also highlighted that the FIR as alleged by the defacto complainant is false, concocted and fictitious in nature.

He will not not tamper with the evidence or hamper the investigation.

It is also submitted that he undertakes to appear before the police or the court, if he is granted relief by way of bail.

Ld. Advocate for the petitioner/accused submits that the accused is in custody since 19.05.2026.

It is also submitted that accused is the only bread earner of the family.

It is further submitted there is case and counter case against the defacto complainant.

Thus, Ld. Advocate has prayed for bail on any terms and condition as this court may deem fit and proper.

It is also undertaken by the Ld. Advocate that the petitioner/accused will abide by the terms & conditions imposed by this court.

Ld. Public Prosecutor opposed the prayer for bail on the ground that petitioner/accused has inflicted serious injury upon the victim and she suffered fracture and was under intensive medical care and hospitalization.

Perused the written complaint, formal FIR, L.C.R. and C.D including the injury report.

Considered.

It is found on perusal of the record that some of the accused persons have not yet been arrested. There is no immediate chance of disposal of investigation.

Keeping in mind the period of detention, I am inclined to allow interim bail to the accused/petitioner.

Hence, it is

ordered

that the accused/petitioner is granted **interim bail** on condition.

Accused/petitioner shall be released on **interim bail** upon furnishing a bond of Rs. 10,000/- with two registered sureties of Rs. 5,000/- each, out of which one must be local, subject to the satisfaction of Ld. CJM, Bankura and also on conditions:

1. petitioner/accused shall meet the I.O. once in a week till submission of report in final form and
2. shall not tamper the evidence or hamper the witnesses; i.d., to J.C. and
3. shall not threat the defacto complainant or witnesses in any manner whatsoever and
4. shall not create hindrance during investigation and
5. shall not enter into the jurisdiction wherein the defacto complainant resides.

Return the C.D.

The Criminal Misc. Application is thus disposed of.
