14 accused persons on C.B are present. Accused Sukuruddin Mallick on C.B is absent by filing an adjournment application . The same is considered and allowed for the ends of justice.

3 custody accused persons namely Sader Ali Mallick, Sundar Ali Mondal and Abdul Jaffar Ali Bhuinya are produced from J/C.

Consideration of charge is adjourned today on the prayer of the accused persons.

Thereafter petition for bail filed by accused Abdul Jaffar Ali Bhuinya is taken up for hearing.

Hd. Ld. Advocate for the aforesaid accused person with reference to the petition for bail when he submitted that this accused voluntarily surrendred before this court on 4.10.18 showing his bonafideness and he is in custody for 70 days, other some co-accused persons have been enlarged on bail and after all investigation has already been completed by way of submission of chage-sheet.

Ld. Additional P.P raised objection against the prayer for bail and submitted that his anticipatory bail application was rejected being not-pressed by Ld. Sessions Judge, Bankura in the month of March, 2018.

Perused the instant petition for bail, case record and C.D.

On being asked Ld. Advocate for the petitioner submitted that no application for bail was rejected before the Hon'ble High court and no application for bail has been pending before the Hon'ble High court in connection with this case in respect of the present accused/petitioner.

Considering the period of detention of the aforesaid accused and considering the fact that investigation has already been complelted, I am of opinion that further detention of accused Abdul Jaffar Ali Bhuinya will not serve any effective purpose.

Consequently the prayer for bail of accused Abdul Jaffar Ali Bhuinya is hereby considered and allowed.

The accused person namely Abdul Jaffar Ali Bhuinya may find bail of Rs. 2,000/- with one registered surety of like amount on condition that he will not make any threat either to the defacto-complainant or to any prosecution witnesses in any manner, subject to the satisfaction of Ld. A.C.J.M. Khatra.

If any such threatening is reported either to this court or to the police station then the court may go for cancellation of his bail without any intimation to the accused person.

Return the C.D.

Fix **6.2.2019** for consideration of charge.

Aforesaid 3 custody accused persons be remanded to J/C till **6.2.19**.

If on bail, aforesaid accused Abdul Jaffar Ali Bhuinya must appear before this court on **6.2.19**.

Let a copy of this order be sent to Ld. A.C.J.M., Khatra for his information and taking necessary action.
