This is an application filed by applicants for issuing succession certificate under section 372 of the Indian Succession Act. In support of their claim, they have filed documents alongwith list Exh.3 alongwith affidavit.

2] It is contended by the applicant that, husband of applicant No.1, father of applicant no.2 to 4 and son of applicant no.5 deceased Bajarang Macchindra Shivsharan died on 23/07/2025 at Thergaon Hospital, Pimpri Chinchwad, Pune and father of deceased Bajarang Macchindra Shivsharan namely Macchindra Satappa Shivsharan was also died on 10/09/2013. Applicants are legal heirs of deceased Bajarang Macchindra Shivsharan. There are no other legal heirs except applicants. At the time of deceased Bajarang Macchindra Shivsharan death he was working at Pune Mahanagarpalika Mahamandal (PMPML) as a badali hangami driver no.4770. Applicants have filed this application to receive the amount laying on the name of deceased

Bajarang Macchindra Shivsharan at PMPML office. An amount of Rs.1,38,830/- (Rs. One Lakh Thirty Eight thousand Eight Hundred Thirty only) which is lying as a amount of provident fund, gratuity etc. in PMPML Office. After the death of deceased Bajarang Macchindra Shivsharan applicants had been went to the PMPML office for receiving the amount laying on the name of deceased Bajarang Macchindra Shivsharan. But, the PMPML officer demanded them succession certificate. In order to receive the said amount, the applicant require succession certificate. Hence, they have prayed for issuance of succession certificate on the name of applicants.

3] In support of their claim, applicants have furnished the documents death certificate of Bajarang Macchindra Shivsharan, death certificate of Macchindra Satappa Shivsharan, letter of PMPML officer along with Exh-3 and copy of Aadhar card of applicants.

4] After completion of all formalities, publication was issued in the daily newspaper "Punya Nagari" dated 14/05/2026 and citation notice published on the office notice board of Civil court, Pimpri and house of applicant, objections were called, but after publication of public notice and citation notice, nobody have raised any objections regarding the claim of the applicants till date. The contentions of the applicants have been supported by an affidavit of evidence of applicants on dt.14/08/2026 which has been unchallenged. Since no objection is given by the applicant no.2 to 5 as they have no objection

to issue succession certificate only on the name of applicant no.1. In my opinion, applicants are only legal heirs of deceased Bajarang Macchindra Shivsharan. Applicant no.2 to 5 have given no objection to issue succession certificate on the name of applicant no.1. Therefore, it would be just and proper to issue succession certificate in favour of the applicant no.1, as prayed.

5] In view of my foregoing discussion, it is crystal clear that, the applicants have prima-facie proved their claim for issuing succession certificate and there is no bar to issue the same in favour of the applicant no.1. In the result, I proceed to pass the following order :-

: ORDER :

1. Application is allowed.
2. Issue Succession Certificate for an amount of **Rs.1,38,830/-** (Rs. One Lakh Thirty Eight thousand Eight Hundred Thirty only) which is lying in PMPML office in the name of deceased Bajarang Macchindra Shivsharan in favour of the applicant no.1 on payment of requisite Court fee stamps.
3. Applicant no.1 shall execute the bond alongwith surety binding her to produce the aforesaid amount as and when called by the Court for the disposal.
