Record is put up today on the strength of put up petition filed on behalf of the accused person namely, Sayed Ali Bayen.

Considering the urgency of matter, the said put up petition is allowed.

One surrender petition is filed on behalf of the above said accused person.

Ld. Advocate for the accused person is present.

Ld. Public Prosecutor In-charge of this case is present.

Ld. Advocate for the accused person has submitted that due to diary mistake and miscommunication of next date, the above said accused person has not appeared on previous date i.e. on 29.02.2024, and due to that reason warrant of arrest was issued against him. He prays for permitting the above named accused person to surrender before this Court.

Ld. Public Prosecutor In-charge of this case has not objected this petition filed on behalf of the above said accused person.

Considering that warrant of arrest was issued against above said accused person, I am of the view that it will be justified to allow the surrender petition filed on behalf of the above said accused person. The accused person is taken into custody and remanded to J/C till 07.03.2024.

One bail petition is filed on behalf of the accused person.

Ld. Advocate for the above said accused person has submitted that this accused person was already on bail, and his absence on the previous date was not intentional. He prays for enlarging this accused person on bail on any conditions.

Ld. Public Prosecutor In-charge of this case has vehemently opposed the bail prayer of this accused person, and submitted that this accused person is habitual absentee and due to his absence the trial of this case is delayed. He prays for rejecting the bail prayer of this accused person.

I have heard the submissions of the Ld. Advocate for the accused person, and Ld. Public Prosecutor In-charge of this case and perused the records. From the records, it is revealed that the said accused person was enlarged on bail by Ld. A.C.J.M, Khatra on 29.04.2022, but because of the misuse of liberty warrant of arrest was issued against this accused person on 29.02.2024. Considering that this accused person was already on bail and his absence on the previous date was not intentional, I am of the view that it will be justified to enlarge the above said accused person on bail on following conditions:

- 1) Accused person will appear in each and every proceeding of the case.
- 2) Accused person namely , Sayed Ali Bayen will furnish bail bond of sum of Rs. 1000/- with two registered sureties of Rs. 500/- each to the satisfaction of Ld. A.C.J.M, Khatra.

To date (09.07.2024) for production / appearance of the accused person and consideration of charge.
