Today is the date fixed for hearing of the bail petition dated 22.12.2021 filed on behalf of the accused Sumanta @ Samanta Murmu.

Ld. Advocate for the said accused person is present.

Ld. P.P. In-charge of this case is present.

Ld. Advocate for the said accused person has submitted that no any bail petition is pending or rejected by any higher Court in respect of the said accused person in this case. Ld. Public Prosecutor In-charge of this case has conceded the said submissions of the Ld. Advocate for the accused person.

Ld. Advocate for the said accused person has submitted that this accused person was already on bail, and due to misuse of liberty warrant of arrest was issued against this accused person by this Court on 05.02.2021, and on the strength of warrant of arrest this accused person was brought under arrest on 17.02.2021, and since then this accused person is in custody. He has further submitted that, this accused person has been falsely implicated in this case. He prays for enlarging this accused person on bail on any condition.

Ld. Public Persecutor In-charge of this case has vehemently opposed the bail prayer of this accused person, and submitted that the allegations against this accused person is very serious and due to misuse of liberty by this accused person the trial of this case is delayed. He prays for rejecting the bail petition of this accused person.

I have heard the submissions of the Ld. Advocate for the said accused person and the Ld. Public Prosecutor in charge of this case, and perused the records including CD. From the records, it is revealed that this accused person got anticipatory bail from the Hon'ble High Court on 14.02.2017 in CRM no. 164 of 2017, and after that this accused person has misused the liberty and due to that reason warrant of arrest was issued against this accused person on 05.02.2021 and on the strength of said warrant of arrest this accused person was arrested. It is also revealed from the records that this accused person is in custody since 17.02.2021. Considering the materials on records specially that this accused person was already on bail and period of custody, I have of the view that, it will be justified to enlarge this accused person on bail on following conditions:-

- 1) Accused person will not intimidate the victim of this case.
- 2) This accused person will not influence any of the witnesses of this case.
- 2) This accused person will appear in each and every proceeding of the case.

3) This accused person namely, Sumanta @ Samanta Murmu will furnish bail bond of sum of Rs. 1000/- with two registered sureties of Rs. 500/- each to the satisfaction of Ld. A.C.J.M Khatra.

With the above observations, bail petition dated 22.12.2021 filed on behalf of the accused Sumanta @ Samanta Murmu is disposed of.
