The accused Ajibul Mia is produced from J.C. physically.

Copies are ready and supply to the accused persons.

Ld. PP in charge and the Ld. Lawyer of the accused are present.

Record shows that WPA against the other accused Rana Barman could not be executed and all the processes were exhausted.

There is no scope to trace out the said accused in near future.

Accordingly, let the case against the accused Rana Barman be filed for the present.

The case record is taken up for framing of charge against the accused Ajibul Mia.

Now the case record is taken up for consideration of charge.

Perused the case record and other materials on record as well as submissions.

On perusal of the case record and the materials on record I find that there are sufficient materials for the offence under section 20(b)(ii)(B) of the NDPS Act against accused Ajibul Mia. Accordingly charge u/s 20(b)(ii)(B) of the The NDPS Act is framed against him. The substance of accusation for the aforesaid charge is read over and explained to the above accused person to which he plead not guilty and claim to be tried.

Formal charge has been framed separately on a separate sheet and kept with the record.

To **29.08.2026** for evidence of CSW No. 1.

Issue summons accordingly.

Prosecution to take steps.

Bail petition filed for the said accused.

Heard Ld. Advocate for the said accused and the Ld. PP-in-Charge.

Record shows that this accused is in custody for misusing the liberty granted to him and it appears that he was released on bail and subsequently proclamation was issued to procure his attendance.

The conduct of the accused not at all satisfactory.

Ld. PP-in-Charge raised strong objection.

Considering the fact that due to various reasons the trial could not be started till now.

Considering all aspects I think another chance may be given to the accused.

The said accused **Ajibul Mia** may be released on interim bail upto 29.08.2026 on his furnishing bond of Rs 5000/- with two registered sureties of Rs 2500/- each to the satisfaction of Ld. CJM, Cooch Behar on condition that he will turn up before this court on each and every date and for his absence of any single date, his bail bond will be canceled and he will be taken into custody.

If on bail, 29.08.2026 for appearance and evidence of complainant.

Let a copy of this order be sent to the Ld. CJM, Cooch Behar for information and taking necessary action.
