This Suit having been finally heard on this day and after considering the matter this court delivered the following:

J U D G M E N T

This suit is one for realisation of money.

2. The defendants appeared and the matter was sent for mediation.

Matter settled the mediation and agreement is filed.

3. Heard both sides and perused the agreement.

4. It is submitted on behalf of the plaintiff that Rs. 4,00,000/- as agreed to be paid by the defendants is received. The defendants have filed I.A. 03/2024 to lift the interim attachment of the property of the defendants ordered in I.A. 2910/2022. No objection is endorsed by the plaintiff in that application. As per the agreement the defendants have agreed to pay Rs.4 Lakh on or before

30.06.2024. It is submitted by both sides that if the amount is received by the plaintiff no decree is to be passed. As agreed by the plaintiff he has filed application to lift attachment on receipt of the amount. The compromise is lawful. Hence it is accepted. Therefore, the suit as well as the counter claim is to be dismissed without costs.

In the result, the suit and the counter claim are dismissed without costs. The plaintiff as well as the defendants are entitled to refund of the court fee paid by them in the suit and the counter claim respectively. The mediation agreement dated 22.05.2024 shall form part of the decree.
