First Bail application under Section 483

ORDER:-

- 1) This application under Section 483 of BNSS, 2023 for grant of regular bail was filed by bail applicant-accused **Jatinder @ Jatinder Singh** on 28.07.2025 in case F.I.R. aforementioned.
- 2) Notice of the bail application was issued to the respondent State and learned Additional Public Prosecutor for the State has contested the bail application. Record of remand papers produced.

3) The learned counsel for the applicant-accused has submitted that the applicant-accused is innocent, has not committed any offence. The applicant-accused is in custody since 02.07.2025. The trial of the case will take a long time and no useful purpose will be served by keeping the accused-applicant in custody.

4) Record perused. The allegations of the prosecution are that the applicant/accused Jatinder Singh @ Jatinder and co accused Rahul apprehended by the police party headed by LR/ ASI Baldev Singh apprehended him in the area of Old Jail, Kapurthala, and applicant at the sight of the police threw away one polythene bag on the road side, which on search conducted by ASI Rajbinder Singh, was found containing 05½ grams of Heroin. CFSL report has not yet been received in this case.

5) As per the case of the prosecution, the recovery of 05 ½ grams of Heroin has allegedly recovered from the the applicant Jatinder @ Jatinder Singh falls in non-commercial quantity. The applicant/accused is already in custody from 02.07.2025. His further custody is not required for any purpose. The challan is not likely to be presented soon. Moreover, the trial will take sufficient long time. Till then the applicant-accused cannot be kept behind the bars. Resultantly, the present bail application is allowed and the applicant/accused is ordered to be released on bail on his furnishing bail bonds in the sum of Rs.30,000/- with one surety in the like amount/cash surety in the like amount to the satisfaction of learned Area/Duty Magistrate Court, subject to the following conditions:-

1. That the applicant/accused shall appear in the Court on each and every date of hearing;
2. That the applicant/accused shall not leave India without prior permission of the court and shall not induce the prosecution witnesses;
3. That the applicant/accused shall not tamper with the prosecution evidence.

6) Copy of this order be sent to the learned Illaqa/ Duty Magistrate forthwith under the signatures of Reader for compliance. The court concerned is directed to send the bail bonds to this Court after acceptance of the same. A soft copy of the bail order be sent by e-mail to the accused/applicant through the Jail Superintendent. Bail application be tagged with the remand papers/file.
