ORDER:-

This common order of mine shall decide two applications for regular bail under section 439 of Cr.P.C filed in the above noted FIR i.e. one filed on behalf of applicant Sandeep Kumar @ Sunny bearing CIS No. BA-1819-2023 and the other on behalf of applicant Mandeep Kumar @ Ganja bearing CIS No. BA-1863-2023, on the allegations that they are innocent and have been falsely implicated in the present case. Nothing has been recovered from the applicants/accused and a false recovery has been planted upon them. Applicants/accused are in custody since 05.06.2023. It will take long time to present the challan and thereafter, in conclusion of trial. No useful purpose will be served by keeping the accused/applicants in custody. Hence, these bail applications.

2. Notice of bail applications was issued to State and Sh. Dalip Kumar, Public Prosecutor put in appearance on behalf of State. Record has also been requisitioned.

3. I have heard arguments of learned counsels for applicants and learned Public Prosecutor for State and have gone through the record.

4. As per report of Filing Branch Clerk, no bail application filed by applicants/accused is pending in the Hon'ble High Court. He has attached on record copy of report downloaded from the website of Punjab and Haryana High Court.

5. As per the case of the prosecution, on 05.06.2023, a secret information was received by the police party that accused Sandeep Kumar and Mandeep Kumar @ Ganja are habitual of snatching mobile phones on motorcycle and on that day, they are present with a motorcycle in order to snatch mobile phone of someone. In case raid is conducted, then they can be apprehended. On raid, applicants/accused were apprehended and two mobile phone were recovered from accused Sandeep Kumar and one from accused Mandeep Kumar and on their disclosure statements, 5 mobile phones each were recovered.

6. Out of the recovered mobile phones, during this period of 49 days, Investigating Agency has collected only ownership of one mobile phone, which is owned by a person from Jammu & Kashmir. There is no criminal history of the applicants/accused. Applicants/accused are

in custody since 05.06.2023. It will take sufficient time to present the challan and to conclude the trial. No useful purpose will be served by keeping the applicants behind bars for indefinite period. Present applications for regular bail are allowed. Applicants/accused are admitted to bail on their furnishing bail bonds and surety bonds to the satisfaction of Illaqa Magistrate/Duty Magistrate. Copy of this order be sent to the trial court. One copy of order be also placed in the file of bail application bearing No. BA-1863-2023 Bail papers be consigned to record room.
