Advocate files a bail petition by his guardian on behalf of the CCL and submits before the Board that there is no bail application filed in respect of the CCL before the Hon'ble Apex Court nor there is any rejection of bail application in respect of the CCL by the Hon'ble Apex Court. Thus the Ld. Advocate for the CCL prays for bail on any terms and condition.

Heard submission of Ld. Advocate for the CCL as well as the Ld. PP-in-charge.

Father of the CCL submits before this Board that he is ready to take custody of the CCL as a fit person and undertakes to ensure his safety, security & welfare.

We have scrutinized the record and considered all submissions.

Perused the CD and the materials available on the case record.

Considering all aspects, we are of view that the safety, security & welfare of the above mentioned CCL shall be ensured if he is placed in the protective custody of his father.

As such bail prayer of the CCL stands allowed.

Father/guardian of aboved mentioned CCL is declared fit person and the custody of CCL is entrusted upon him, if not wanted any other cases.

Father of the CCL shall furnish guardian bail bond of Rs. 1000/- upon condition to ensure safety, security and welfare of the CCL at all times; ensure not to make any association with bad character persons or para people or to any person acquainted with the facts of the to dissuade him from disclosing to the case so as such fact to the Board or Investigating Officer/any Police Officer.

If on bail, fix **29-01-2025** for appearance of CCL, Copy Supply and Plea.

CD be returned through GRO of this Board at once.
