This is an application for confirmation of interim bail granted by this court in favour of the accused / petitioners namely **1) Rousan Routhy and 2) Riky Mahato** passed on 25/02/2026 in Bail Petition No. 173 of 2026 arises out of Sadar Women P.S. Case No. 08 / 2026 dated 19/01/2026, under section 115(2), 79, 308(3), 351(2), 3(5) and adding section 64 of the Bharatiya Nyaya Sanhita, corresponding to G.R. Case No. 83 of 2026.

Ld. advocate for the accused / petitioners is present.

Ld. Public Prosecutor is also present.

Case Record of the Ld. Trial Court and Case Diary have been produced.

So, the matter is taken up for hearing.

Heard Ld. advocate for the accused / petitioners as well as Ld. Public Prosecutor.

When investigation has been completed, Ld. advocate prays for confirmation of interim bail granted by this Court to the petitioners on 25/02/2026.

Ld. Public Prosecutor leaves the matter to the discretion of the Court. He also submits that charge sheet has already been submitted after completion of investigation.

Perused the Case Record as well as Case Diary.

Also perused the order No. 4, dated 25/02/2026 passed in Bail Petition No. 173 of 2026.

It appears from the case record that charge sheet has already been submitted after completion of investigation.

Having heard submissions of both sides and also considering the present circumstances of the case when charge sheet has already been submitted, the interim anticipatory bail granted to the accused / petitioners on 25/02/2026 in Bail Petition No. 173 of 2026 is hereby **confirmed**.
