Received charge sheet, FSL report, CCTNS copy & list relied documents vide charge sheet No.191/2026 dated 07-06-2026 U/sec. 21(C)/27A/25/29 of NDPS Act against **two** accused persons namely **1)Aminur Hossain** who is in custody & **2) Jahangir Hoque** who is absconded in connection with Dinhata P.S Case No. 601/2025 dated 14-12-2025.

Copies of the documents which are reliable in connection with the case are also submitted by the I.O for supplying the same to the accused persons.

I have perused the case diary along with written complaint, statement of witnesses recorded u/s 161 of Cr.P.C., seizure lists and other materials on the case diary.

After careful perusal of the case diary it appears that there is sufficient prima facie materials for the offence U/sec. 21(C)/27A /25/29 of NDPS Act against both accused persons **1) Aminur Hossain & 2) Jahangir Hoque.**

Accordingly, cognizance for the offence U/sec. 21(C)/25/27A/29 of NDPS Act **is taken** against the accused persons **1)Aminur Hossain & 2) Jahangir Hoque.**

The I.O of this case intimated that accused Jahangir Hoque was allowed the anticipatory bail before Hon'ble Calcutta High Court, Circuit Bench at Jalpaiguri vide CRM(A) No. 36 of 2026. But on perusal of the case record it appears that accused Jahangir Hoque did not appear before this court till today.

Accordingly issue notice upon the absconded accused Jahangir Hoque at once.

The prayer of I.O for discharge accused **Tinku** will be considered after appearance of defacto complainant.

Defecto complainant SI Sudhabrata Mukharjee of Dinhata P.S is directed to remain present on the date fixed.

The I.C Dinhata P.S is directed to instruct the defecto complainant and I.O of this case to be present on the date fixed.

Let the case be registered as NDPS Case.

Let a copy of this order be sent to the I.C Dinhata P.S for information and taking necessary action.
