ORDER

1. Vide this first application under Section 483 BNSS, applicant-accused has sought regular bail in FIR No.103 dated 11.12.2024, under Section 21-61-85 of NDPS Act , Police Station Behram, District SBS Nagar.

2. Notice of the application has been given to the State pursuant to which learned Addl. Public Prosecutor for the State has put in appearance. As reported by the learned Addl. Public Prosecutor for the State no other bail application of applicant-accused is pending in any other court of law including Hon'ble High Court.

3. Brief facts, relevant for disposal of present bail application, are that applicant-accused was intercepted by the police on 11.12.2024, who on seeing the police party, applicant-accused threw out plastic envelop from the window of his car make ETIOS make Grey Colour bearing registration No.PB-32-T-5567 on the road and was apprehended on suspicion. From the transparent plastic envelope, thrown by applicant-accused 10 grams Heroin, was recovered.

4. The recovery in the present case is non-commercial. Applicant-accused is in custody since 11.12.2024. The presentation of challan and conclusion of trial shall take time. The bail application is accordingly allowed and applicant-accused is ordered to be released on bail on his furnishing personal bond and surety bond to the satisfaction of Illaqa/Duty Magistrate, subject to the following conditions:-

- (i) that applicant-accused will appear on each and every date of hearing before the Court;
- (ii) that applicant-accused will not tamper with the prosecution evidence;
- (iii) that applicant-accused will not leave India without prior permission of the Court;
- (iv) Applicant-accused shall not repeat or commit any offence and if he is found to have repeated any such like offence, it shall be open for the investigating agency to bring it to the

notice of the Court and to pray for cancellation of bail of applicant-accused.

5. Ahlmad is directed to send the copy of order through E-mail to the Superintendent of concerned Jail, as well as, to Secretary, D.L.S.A., Shaheed Bhagat Singh Nagar. Bail application file be consigned to the Record Room.
