ORDER :

1. Today, on behalf of accused/applicant Sh.Surmeet Singh Sandhu, Advocate filed his power of attorney, which is taken on record. ASI Balwinder Kumar has come present along with record pertaining to

this bail application. Arguments heard. During course of argument Ld.Adll PP for the state that on 07.04.2021 when ASI Tarlochan Singh alongwith his police party was present at Chuggiti Chowk, Jalandhar, then he received a secret information that Jarnail singh and Jarmal Singh, who are in habit of committing robberies are coming on a stolen motorcycle laced with weapons in order to commit robbery. Finding this information quit credible, naka was imposed and motorcycle of accused was intercepted. The person, who was driving the motorcycle namely Jarnail Singh could not produced any document to establish the ownership of motorcycle. Then, on his personal search one. 32 bore pistol alongwith three live cartridges and two magazine was recovered. The person, who was sitting/riding on the pillion seat namely Jarmal Singh was searched. Then, on his search one 32 bore country made pistol alongwith four live cartridges and one magazine was recovered. At the time of recovery, motorcycle was bearing no.PB09AH3098 but on verification, it was found registered with registration authority in UP and actual registration number is UP-11BA-9666. Meaning thereby, accused were moving on a stolen motorcycle having fake number plate.

2. Whereas, recovery has already been effected and no previous bad record of the accused applicant has been traced. Now, accused is in custody from the date of his arrest i.e. 10.04.2021 whereas, it would take time for the prosecution to complete the investigation and then to present the challan. So, no useful purpose would be served by unnecessarily detaining the applicant in custody.

3. Therefore, accused applicant is admitted to regular bail and is

ordered to be released on bail on his furnishing bail bonds in the sum of Rs.75,000/- with one surety in the like amount to the satisfaction of Illaqua/duty Magistrate. File be consigned to the record room.
