ORDER

The instant application preferred U/s 438 of Cr.P.C. for the grant of anticipatory bail has been received by entrustment. It be registered. Notice to the ld. Addl. PP served. Record of the concerned police station be called for 22.07.2019

2) Learned counsel for the applicants submitted that a false case has been filed by the complainant with totally false and frivolous allegations and no such offence whatsoever is made out against the applicants from the bare perusal of the allegations of the complainant. No

injury has been caused by the applicants and the complainant has made a concocted story just to implicate the present applicants along with other family members in the present case. Nothing is to be recovered from the present applicants and there is no need of custodial interrogation of the applicants. The applicants are ready to join the proceedings. With these submissions, he requested for according interim bail to the applicants till the final decision of this bail application.

3) Heard. At this juncture, without going into the merits of the instant case, the aforesaid applicant-accused namely Mehak Singh @ Gurmehakpreet Singh, Gurkaran Singh @ Gurkarandeep Singh, Rajan @ Rajinder Singh are hereby, directed to cause appearance before the SHO/IO of the PS City Patti and in case they do so, they will be admitted to ***interim bail*** till 22.07.2019 on their furnishing the bail bonds in the sum of ₹ 50,000/- with one surety in the like sum each of the applicants to the satisfaction of IO/SHO of PS City Patti, Tarn Taran with the direction that the applicants will not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him/her from disclosing such facts to the Court or to any police officer and the applicants will not leave the country without the prior permission of the Court.
