The witness namely **Bikash Kanti Dey**, Erstwhile IC of Haldibari PS, Now posted as Deputy Superintendent of Police, Special Task Force, Salt Lake, West Bengal has appeared before the Court through VC at 3.00 PM. He is examined and cross-examined as PW10 through VC in full and discharged.
