ORDER BELOW EXH. 07

(Order passed on 11/08/2026)

This is an application filed by the applicant i.e. brother of the accused under section 503 of The Bharatiya Nagarik Surakha Sanhita, 2023.

2 Sessions Case No. 78/2026

2] It is submitted by the applicant that he is the brother of accused No.2 and he is registered owner of vehicle i.e. Ertiga VXi (O) CNG, Colour : Pearl Arctic White, bearing registration No. **MH-44-U-3615**, Chassis No.MA3BNC62SRH873508, Engine No.K15CN9598070. The police has seized the above said Car in CR no. 271/2026 registered with Mahalunge police station for the offence punishable under section 103(1), 238, 61(2), 3(5) of B.N.S. The applicant is a registered owner of the said Car and the said is required by him for his day to day affairs. Hence, applicant prayed that custody of seized vehicle be handed over to him. He will obey the terms and conditions of the order and shall not misuse the vehicle.

3] The prosecution opposed the application on a ground that the said vehicle is involved in the crime and it was used while commission of offence. It is one of important piece of evidence. If the seized property is handed over to the applicant, he will not produce it as and when required by the Court. Further there is possibility of transfer of vehicle and delay in the trial. Hence, prayed for rejection of application.

4] Perused application, say filed by the prosecution. Heard both advocate at length.

3 Sessions Case No. 78/2026

5] It is a matter of fact that the investigation in the present crime is completed and charge-sheet is filed. The vehicle was seized from the custody of the brother of the applicant who is accused in the present crime. The applicant is registered owner of the vehicle i.e. Ertiga VXi (O) CNG, Colour : Pearl Arctic White, bearing registration No. **MH-44-U-3615**, Chassis No.MA3BNC62SRH873508, Engine No.K15CN9598070. Admittedly, the seized property is a vehicle and if the same is permitted to lie ideally in the police station its body part and spare parts will get damaged. Admittedly, said vehicle is required for day to day affairs and activity. The applicant has filed on record the copy of RC book and Aadhar Card, which shows that he is registered owner of the seized Car. If the property is not handed over to the applicant, it will diminish and will get damaged which will cause financial loss to the applicant. Therefore, certainly applicant is entitled for the custody of the seized vehicle i.e. Car, subject to certain conditions. Considering this I pass following order.

O R D E R

1. Application is allowed.
2. The seized vehicle i.e. Ertiga VXi (O) CNG, Colour : Pearl Arctic White, bearing registration No.**MH-44-U-3615**, Chassis No.MA3BNC62SRH873508, Engine

4 Sessions Case No. 78/2026

No.K15CN9598070, be handed over to the applicant by accepting indemnity bond of Rs. 5,00,000/- from the applicant on following conditions:-

- (a) The investigating officer is directed to prepare detail panchanama, take the photographs of the vehicle before handing over to the applicant.
 - (b) The applicant is directed not to alienate, transfer or dispose of the vehicle till decision of this case.
 - (c) The applicant is further directed not to change colour or structure of the vehicle till decision of this case.
 - (d) The applicant is further directed to produce the alleged vehicle as and when required during trial.
3. Application is disposed off.
