

G.R No. 575/2014

Order No.21, dt. 26.08.2022 :-

Today is fixed for E.R of W/A against accused Chandan Roy, Madan Roy and Suniti Roy.

Two accused persons namely, Chandan Roy and Madan Roy voluntarily surrendered before the court by filing a petition and pray for bail on the ground stated therein and they are taken into custody.

Ld. P.P and Ld. Advocate for the accused are present.

Ld. Advocate for the accused persons submits that previously accused persons were enlarged on bail but due to miscommunication they could not come to court on 07.06.2022 and as such W/A were issued against them by this court. He further submits that if the accused persons are enlarged on bail, they will not flee away and attend the court regularly. On this ground accused prayed for bail.

Ld. P.P raised objection.

Heard both sides in respect of the bail matter. Considered.

Perused the case record and other materials on record.

So, considering that accused persons voluntarily surrendered before the court and also considering the submission of Ld defence counsel, I am inclined to enlarge both the accused persons on bail.

Accordingly both the accused persons namely Chandan Roy and Madan Roy may find bail of Rs. 1000/- each with one registered surety of like amount, subject to the satisfaction of this court, i.d. to J/C till 08.09.2022. If on bail to 19.04.2023 for appearance.

Another petition is filed by the accused persons through Ld Advocate that accused Suniti Roy expired on 10.05.2022 along with photocopy of death certificate.

Perused. Compared with the original. Heard. Considered. Accordingly the case against the accused Suniti Roy is filed for ever. Note into T.R and C.S accordingly. Original death certificate be returned at once.

To 19.04.23 for appearance of two accused persons and evidence of CSW No. 3 and 6.

Issue summons accordingly.
