A W A R D

The dispute between the parties having been referred for determination to the Lok Adalat and the parties having compromised/settled the case/matter, the following award is passed in terms of the settlement:

2) The Petitioner and Respondent Insurer have settled the claim for **₹ 2,40,000/- (Two lakh forty thousand only)** as full and final settlement. The above amount shall be deposited to the credit of the Bank Account of the Motor Accidents Claims Tribunal, Ottapalam shown below, directly by National Electronic Fund Transfer (NEFT)/ Real Time Gross Settlement (RTGS) or any other electronic mode, within 30 days.

3) Respondent/Insurer shall instruct their bank to ensure deposit of the Award amount by way of Direct Bank Transfer to the account of the Motor Accidents Claims Tribunal, Ottapalam shown above containing following information in the prescribed format(which is already circulated) by way of compliance of the Award.

4) On such deposit being made Respondent/Insurer shall submit a letter to this Tribunal enclosing a copy of said bank advice in the prescribed format(which is already circulated) as per which deposit was made to the bank account of this Tribunal.

5) Respondent/Insurer shall also send a copy of payment advice to the Motor Accidents Claims Tribunal concerned and serve a copy of the same on the claimants or their counsels.

6) The Motor Accidents Claims Tribunal, Ottapalam shall ensure that as and when the Award amount is received in the Bank Account of MACT, it shall be

disbursed to the credit of the bank accounts of claimants shown below directly by way of NEFT/ RTGS or any other electronic mode.

8) In default to remit the amount as above mentioned, the Respondent /Insurer shall be liable to pay the above amount with interest thereon at the rate of 9% per annum from the date of default until the payment of full amount due to the petitioner.
