This is an application under section 439 of Cr.P.C filed by the accused/petitioner **Arjiya Bibi @ Ejiya Bibi** in connection with G.R Case No. (I)44 of 2026 corresponding to Sitai P.S Case No. 16/2026, dated-30-01-2026, under sections-126(2)/118(2)/109(1)/3(5) of BNS.

Ld. Advocate for the accused submitted that the accused is falsely implicated in this case and she is innocent. Ld. Advocate for the accused further submitted that the accused is in judicial custody for considerable period and she may be released on bail. Ld Advocate for the accused further submitted that no bail application has been filed or pending before the Higher court.

Heard Ld. P.P in-charge who raises objection.  
Perused the case diary.

From the case record it reveals that one Ajidul Miah and his mother, that is, the instant accused person, namely, Arjiya Bibi @ Ejiya Bibi were arrested and they were produced before the Ld. Court of A.C.J.M, 2<sup>nd</sup> Court, Dinhata on 31-01-2026. Perused the statements of accused persons, namely, Ajidul Miah and Arjiya Bibi @ Ejiya Bibi as recorded by the I/O and from therein accused Ajidul Miah admitted his guilt and accused Arjiya Bibi @ Ejiya Bibi admitted that she helped her son accused Ajidul Miah in the commission of the said offence and thereby the instant accused person seems to be an abettor. Perused the seizure-list dated 02-02-2026 wherefrom it reveals that one iron axe with wooden handle was seized from the house of the instant accused persons and as shown by P/C accused Ajidul Miah. Perused the injury report of Ramjan Miah which speaks that the nature of injury is grievous. The coloured photographs of the injured person of Ramjan Miah corroborates the said nature of injury. From the case record it reveals that on 10-03-2026 the Bail Application in respect to the instant accused person was rejected in connection with Bail Application No. 37/2026 and there is no change in circumstances today.

Considering the aforesaid facts the instant bail application of accused person, namely, **Arjiya Bibi @ Ejiya Bibi is rejected.**

This Bail Application thus, stands disposed of.
