Order No. 55, dt. 24.09.2025 :-

Accused Goutam Roy is produced from J/C through V/C.

Today is fixed for production of accused, hearing of bail petition and hearing of petition regarding transfer of the instant case.

Ld P.P in charge and Ld defence counsel are present.

CD is produced.

Heard on behalf of petition regarding transfer of the instant case.

Ld. PP-in-Charge produced a notification being no. **1040-I.S.S. dated the 17th day of August, 2016**, wherefrom it clearly seen that only this Court is empowered to try cases of this nature and the Ld. PP-in-Charge could not substantiate his prayer for transfer of the case by producing any documents. In view of the same, petition for transfer of case is considered and **rejected**.

Now the bail petition is taken up for hearing in presence of both sides.

Heard both sides in respect of the bail matter.

Considered.

Ld Advocate for the accused submits that accused has been falsely implicated in this case and accused is in custody since long and he will face the trial by appearing on each and every dates without any fail, if he is enlarged on bail imposing any condition.

Ld P.P-in-charge opposes the bail prayer.

Perused the record, CD and other materials in connection with this case record. It appears from the case record that accused is in custody since 03.07.2025. It also appears that no further development is seen in the investigation. So, considering the period detention and when there is no further development in the investigation, I think further detention of the accused behind the bar will not serve any purpose of the investigation.

Accordingly, accused Goutam Roy be released on **interim bail** of Rs. **20,000/-** with two registered sureties of Rs. **10,000/-** each of whom one must be a **local**, subject to the satisfaction of Ld. CJM, Cooch Behar, with further conditions :-

1) that the accused shall furnish their PAN, Aadhar Card, Voter ID, Passport, contact details & mobile number at the time of furnishing bail bond and keep the same operational during pendency of the investigation as well as further proceeding of the case and deposit his respective Passport, if any, and PAN, Aadhar, Voter ID before the IO, of this case before furnishing of bail bond and submit receipt before the Ld. CJM, Cooch Behar while furnishing bail bond.

2) The accused shall attend the Court personally on each day and did not execute any document, registered or unregistered without the leave of the Court and shall not operate his bank accounts without the leave of the Court.

3) Accused shall furnish the details of his near relatives with all necessary details, alongwith the bond, under an affidavit and in case the information is found to be false or incorrect, his bail shall be cancelled forthwith.

4) The accused shall meet the IO once a week till investigation is over and assist the IO with all cooperation during investigation.

5) In case of change of residential address or contact details the accused shall promptly inform the same to the IO as well as this Court and failure to comply any one of the conditions will render the bail subject to cancellation.

The bail prayer is disposed of in the above terms and conditions.

If on bail, **01.11.2025** for appearance of the accused and IO's report.
