ORDER:

1) Record received. Heard. It is mentioned in the instant bail application that accused/ applicant has been falsely implicated in this case and she has not committed any offence. It is further averred that nothing incriminating has been recovered from the accused/ applicant and the alleged recovery has been planted upon her. It is further averred that the accused/ applicant is in custody since 02.04.2026 and presentation of challan and conclusion of trial will take long time and no useful purpose would be served by detaining the applicant in custody. Hence, it is prayed that applicant/accused may kindly be released on bail.

2) Learned counsel for the applicant/accused while arguing in the lines of bail application contended that same may be allowed.

3) Conversely, learned Additional Public Prosecutor for the State contended that there are serious allegations against the applicant/ accused and therefore, bail application may be dismissed.

4) After hearing rival submissions, it has transpired that instant case FIR was registered when on 02.04.2026, accused/ applicant alongwith co-accused was apprehended and from them, 07 gm heroin alongwith Rs.25000/- drug money and scooter bearing registration No.PB-03BJ-9661 was recovered. The contraband is of non-commercial quantity in the present case. Chemical examiner report is yet to be received. There is nothing on record to show that the money recovered from the accused is drug money, which shall be matter of evidence. Accused is no more required for custodial interrogation. Presentation of challan and conclusion of trial shall take considerable long time and no useful purpose will be served by keeping the applicant/ accused behind bars. As such, instant bail application is allowed and applicant/ accused is ordered to be released on bail on her furnishing bail bonds to the satisfaction of Illaqa/ Duty Magistrate with the condition that applicant/ accused will neither leave the country without prior permission of the Court nor she will tamper with the witnesses of the prosecution and she will appear before the learned trial Court on each and every date of hearing. Bail application file be attached with remand papers/ main file.
