O R D E R

1. Arguments heard on the bail application filed by Prince Kumar under section 438 Cr.P.C. for grant of bail. Notice of this bail application was given to Additional PP for the State.
2. As per the prosecution version on 09.01.2018 Anil Suri Managing Director Hotel Sawera Grand gave an application to the police that someone named Ekam has made a review on the website of Hotel by giving a mobile No.98784-15150 with regard to 'Escort service' of females due to which

name of his hotel has been defamed and several bookings have been cancelled. So a trap was laid to break the network and on calling the mobile number above mentioned Ekam demanded Rs.20,000/- to send prostitute and ASI Rohit Sharma was prepared as a bogus customer and the place of meeting was fixed at Hayat Hotel, Amritsar, where two persons with one female came on car bearing registration No.PB-02-DD-7061 and two persons named Sahil Khajuria, Jaspal Singh and one female named Aarti were apprehended after striking the bogus deal and they disclosed Ekam is actually Prince Kumar alias Sunny and has made several websites and is running brothels and disclosure statement of Aarti was also recorded. The ID proofs of Prince with different addresses and photographs were also recovered. Prince Kumar alias Sunny and Avinash have prepared fake Aadhar card and voter ID card having different names and have used the same to get the mobile connections on the basis of fake documents. So, FIR was registered.

3. The learned counsel for the bail applicant argued that he is implicated in a false case. He is innocent. He is in judicial custody from a long period. Conclusion of investigation and presentation of challan will take long time. Co-accused have been granted bail. Applicant has not prepared any fake document as alleged. He will abide by the terms and conditions of bail order and prayer is made for grant of bail.

4. Whereas the learned Additional PP has opposed the bail application

stating that keeping in view the gravity of matter accused is not entitled to concession of bail.

5. Heard. Record perused. As per record the applicant has obtained the mobile connections from Internet Service provider on the basis of fake Aadhar card and voter ID Card particulars of which does not match with each other and by using the fake documents as genuine the applicant has succeed in getting the mobile connection which has been misused for running websites for escort service/call girls. So, in view of gravity of matter the applicant is not entitled to concession of bail. Hence, the bail application is hereby dismissed.

6. Anything observed herein will have no effect on the merits of the case. Record of bail application be consigned to the record room.
