ORDER:

1. By this order, this Court intends to deal with the present bail application under Section 438 Cr.PC having been filed by applicants Manohar Lal and Manish Kumar.

2. Notice of the bail application was served upon the State/respondent through learned Additional PP alongwith copy of bail application who appeared to contest this bail application.

3. I have heard the respective contentions of both the learned Advocates and have perused the record with their able assistance.

This application under section 438 Cr.PC has been filed by the applicants by apprehending their arrest on account of their summoning by the Learned Illaqa Judicial Magistrate in the complaint under section 323, 382, 326, 506, 148, 149 IPC. Since, the applicants have been summoned to face trial in a complaint case, custodial interrogation of the applicants is not in question in this case. Accordingly, before finally deciding this bail application on merits, the applicants are directed to join the proceedings before the learned Trial court/duty Magistrate by surrendering there and in the event of their

doing so, learned Trial court/Duty Magistrate is directed to release them on bail on their furnishing bail bonds to his satisfaction and subject to the conditions under Section 438 (2) Cr.PC.

5. Bail application stands adjourned to 05.10.2021 for report of compliance and arguments for final disposal of this bail application.
