**ORDER**

1. Bail application put up before me being Vacation Judge as Ld. Presiding Officer is availing Summer Vacations. ASI Kulwinder Singh, no. 1577/Btl. P.S. Ghanie Ke Banger appeared in the court and made a statement that the accused/applicants Gurmej Singh, Angrej Singh and Sohan Singh have joined investigation in compliance of order dated 13.06.2023 on 22.06.2023 and 24.06.2023 and they are no more required for the purpose of further investigation.

2. Arguments on bail application under Section 438 of Cr.PC for pre-arrest under Sections 326/323/148/149 of IPC and record perused.

3. From the perusal of record, it transpires that vide order dated 13.06.2023 passed by the Court of Sh. Parminder Singh Rai, Additional District & Sessions Judge, Gurdaspur, the present accused/applicants were granted interim bail for the offence under Sections 326/323/148/149 of IPC with the direction to join investigation.

4. From the statement of ASI Kulwinder Singh, it is crystal clear that the present accused/applicants have duly joined investigation in compliance of order dated 13.06.2023. Keeping in view the fact that the accused/applicants Gurmej Singh, Angrej Singh and Sohan Singh have joined investigation and complied with the order aforementioned, the bail order dated 13.06.2023 is made absolute subject to the conditions as envisaged under Section 438(2) Clauses (i), (ii) and (iii) of Cr.P.C enumerated as under:-

*1) That accused/applicants shall make themselves available for interrogation by a police officer as and when required;*

*II) That accused/applicants shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade them from disclosing such facts to the court or to any police officer;*

*III) That accused/applicant shall not leave India without the*

*previous permission of the the court;*

5. However, nothing observed or expressed above in this order shall have any bearing on the merits of the main case. Police record be returned and papers of bail application sent back to the concerned Court for the consignment purpose.
