ORDER.

1. Arguments heard.

Rajwinder Kaur, Additional Sessions Judge, Fast Track Court, Exclusively dealing with Rape Cases, Ferozepur. UID No. PB0121.

2. In the present case after hearing arguments on behalf of Ld. counsel for ***Premo Bai and Amarjit Kaur*** (applicants/accused) and Ld. Addl. Public Prosecutor for the State, the applicants/accused was granted **interim anticipatory bail vide order dated 05.09.2024** and was directed to appear before the investigating agency. Today learned Addl. Public Prosecutor for the State has stated at bar that ***Premo Bai and Amarjit Kaur*** (applicants/accused) have **joined the investigation in this case on 07.09.2024**. ***ASI Jagtar Singh No.471/FZR*** now posted at police station **Sadar Ferozepur**, is also present in the court along with police record, who has *suffered* statement that ***Premo Bai and Amarjit Kaur*** (applicants/accused) have **joined the investigation of present case on 07.09.2024** as per **order dated 05.09.2024** and they are no more required for the purpose of further investigation.

3. In view of statements of learned Addl. Public Prosecutor for the State as well as of ***ASI Jagtar Singh No.471/FZR*** now posted at police station **Sadar Ferozepur**, who has brought police record and affirmed the fact of joining of investigation by the applicants/accused, coupled with the fact that they are no more required for the purpose of

further investigation, **order dated 05.09.2024** vide which interim bail was granted to ***Premo Bai and Amarjit Kaur*** (applicants/accused), the same is made absolute, subject to the conditions mentioned therein. Accordingly, bail application is disposed off.

However, these observation of mine shall have no effect on the merits of the case. File be consigned to record room after due compliance.
