Received one split-up case record from Ld. C.J.M, Cooch Behar in c/w above mentioned case no. Pundibari PS Case No:220/2025 dt: 27-02-2025 along with order sheets, C/C of Formal FIR, C/C of Written Complaint and other relevant documents.

Both the CCLs are present today along with their guardian/zimmaradar in compliance of order No:05 dated 14-01-2026 passed by the Ld. C.J.M, Cooch Behar.

They are taken into safe custody.

Zimmaradar/guardian of the CCLs are present today to take custody of the CCLs as fit persons.

Ld. PP-in-charge is present. No members are present due to dissolution of earlier Board on 19.10.2025.

Perused the case record and the date of birth of the CCLs, it appears that the date of birth of the CCL namely Samrat Dey is on 06.05.2007, CCL namely Pradip Dey is 03.10.2008 and the date of offence is on 01.12.2025 which suggests that they were 17 years 09 months and 20 days and 16 years 4 months and 23 days old on the date of alleged incident.

As such they were children on the date of alleged incident.

Thus the case is received and registered in the trial register.

Ld. Advocate files a bail petition along with fresh vokalathnama by her guardian/zimmaradar on behalf of the CCLs and submits before the Board that there is no bail application filed in respect of the CCL before the Hon'ble Upper Court nor there is any rejection of bail application in respect of the CCLs by the Hon'ble Upper Court. Thus Ld. Advocate for the CCLs submits for bail on any terms and condition.

Now the record is taken up for bail hearing.

Heard submission of Ld. Advocate for the CCLs as well as the Ld. PP-in-charge.

I am interacted with the CCLs at full length and also rendered her proper counseling and scrutinized the record, considered all submissions.

Counseling has been done by the Counselor of this Board.

Zimmaradars/Guardians of the CCLs submits that they are ready to take custody of the CCLs as fit persons and undertake to ensure their safety and security.

Considering all aspects, we are of view that the safety, security & welfare of above mentioned CCLs shall be ensured if they are placed in the protective custody of their guardian/zimmaradar.

As such bail prayer of both the CCLs stands allowed.

Zimmaradars/guardians of aboved mentioned CCLs are declared fit persons and the custody of CCLs are entrusted upon them, if not wanted in any other case.

Zimmaradars/Guardians of the CCLs shall furnish guardian bail bond of Rs. 1000/- each upon condition to ensure safety, security and welfare of the CCLs at all times; CCLs are directed not to enter into the local area of the victim or not enter into the Place of occurrence, not to contact in any fashion the family of the victim

or visit their house, ensure not to make any association with bad character persons or para people or to any person acquainted with the facts of the to dissuade him from disclosing to the case so as such fact to the Board or Investigating Officer/any Police Officer.

Call for Social Investigation Report from Probation Officer, Cooch Behar within 15 days from date of issue.

Call for Social Background Report from C.W.P.O of Pundibari PS.

Let a copy of this order be sent to C.W.P.O of Pundibari PS through O/C of Pundibari PS for his information and taking necessary action.

Call for C/C of CD from the concern PS.

Let a copy of this order be sent to the O/C of Pundibari PS for his information and taking necessary action.

D.A to comply.

If on bail, fix **30-01-2026** for appearance of both the CCLs, SIR, SBR and receiving CD from the concern PS.

Later:

Mother/Guardian namely Golapi Dey of the CCL namely Samrat Dey and mother/guardian namely Dipti Dey of the CCL Pradip Dey furnished guardian bail bond of Rs. 1000/- each on behalf of the CCLs which are found fit, correct and accepted.

Release the CCLs at once if not wanted any other case.
