Principal Magistrate that there is no bail application filed in respect of the CCL before the Hon'ble Upper Court not there is any rejection of bail application in respect of the CCL by the Hon'ble Upper Court. Thus the Ld. Advocate for the CCL prays for bail on any terms and condition.

Heard submission of Ld. Advocate for the CCL as well as the Ld. PP-in-charge.

Ld. PP raised formal objection.

Father /guardian is present before the Board and he stated that he is ready to take custody of the CCL as a fit person and undertakes to ensure his safety, security & welfare.

We have scrutinized the record and considered all submissions.

Considering all aspects and his voluntariness, we are of view that the safety, security & welfare of above mentioned CCL shall be ensured if he is placed in the protective custody of his guardian/father.

As such bail prayer of the CCL stands allowed on A.I basis.

Father/guardian of aboved mentioned CCL is declared fit person and the custody of CCL is entrusted upon him, if not wanted any other case.

Father/guardian shall furnish A.I bail guardian bond of Rs. 1000/- upon condition to ensure safety, security and welfare of the CCL at all times and to appear on all dates during inquiry, not to leave jurisdiction of this Board until further order, not to contact with the victim or their family or visit their house I/d to protective custody in observation home.

Recall Warrant Of Production Upon the CCL namely Faris Khan, S/O- Md. Ziauddin of Yairipok PS, Malom Jaliyanbi, Dist- Thoubal, Manipur by next date fixed positively.

Let a copy of this order be sent to the Station House Officer of Yairipok PS, Malom Jaliyanbi, Dist- Thoubal, Manipur for his information and taking necessary action.
