Today is fixed for appearance of the CCL.

CCL has voluntarily surrendered before Ld. Principal Magistrate today.

He is taken into safe custody.

Ld. P.P. is present. No members are present due to dissolution of earlier Board on 19.10.2025.

Grandfather/guardian of the CCL is also present today to take custody of the CCL as a fit person.

Ld. Advocate files a bail petition along with fresh vokalathnama by his guardian/grandfather on behalf of the CCL and submits that there is no bail application filed in respect of the CCL before the Hon'ble Upper Court nor there is any rejection of bail application in respect of the CCL by the Hon'ble Upper Court. Ld. Advocate for the CCL prays for bail on any terms and condition.

Ld. PP raised objection.

Heard submission of Ld. Advocate for the CCL and the Ld. PP-in-charge.

Perused the materials available on the case record.

Grandfather/guardian is present and he submits that he is ready to take custody of the CCL as a fit person to undertake to ensure his safety, security & welfare.

We have scrutinized the record and considered all submissions.

Considering all aspects, the safety, security & welfare of the above mentioned CCL shall be ensured if he is placed in the protective custody of his grandfather/guardian.

As such bail prayer of the CCL stands allowed.

Grandfather/guardian of aboved mentioned CCL is declared fit person and the custody of CCL is entrusted upon him, if not wanted in any other case.

Grandfather/guardian of the CCL shall furnish bail guardian bond of Rs. 1000/- upon condition to ensure safety, security and welfare of the CCL at all times; ensure not to make any association with bad character persons or para people.

CCL is directed not to enter into the local area of the victim or not enter into the Place of occurrence, not to contact in any fashion the family of the victim or visit their house and he shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the to dissuade him from disclosing to the case so as such fact to the Board or Investigating Officer/any Police Officer.

Call for C/C of CD in c/w this case by next date fixed.

Grandfather/Guardian of CCL namely Kshitish Chandra Sarkar furnished bail guardian bond of Rs. 1000/- on behalf of the CCL which is found fit, correct and accepted.

Release the CCL at once if not wanted in any other case.
