

Electricity Case No. 216 of 2023

Order No.02, dt. 29.09.2023 :-

Record is put up today by a put up petition. Perused. Heard. Considered and put up petition is allowed.

Accused Mani Sarkar voluntarily surrenders before the court by filing a petition along with fresh vokalatnama and photocopy of aadhaar card and notice u/s-41(A) Cr.P.C and prays for bail on the ground stated therein and he is taken into custody. Copy served.

Ld P.P in charge and Ld Defence Counsel are present.

Ld counsel on behalf of accused submits before the court that accused is totally innocent and he has his hearth and home within the jurisdiction of this court and if he is enlarged on bail, he will not flee away and attend the court regularly. Ld counsel also prays for bail on the ground that accused complied the notice u/s-41(A) Cr.P.C and he will deposit the provisional assessment bill to the Electricity Department which was assessed by the concerned department by installments as he is very poor. On this ground accused prayed for bail.

Ld P.P in charge raised objection.

Heard both sides in respect of the bail matter. Considered.

Perused the Case record and other materials on record.

Considering that accused voluntarily surrenders before the court and also considering the submissions of Ld counsel regarding payment, I am inclined to enlarge this accused on interim bail.

Accordingly, accused person namely Mani Sarkar may find interim bail of Rs.500/- with one registered surety of like amount subject to the satisfaction of this court on condition to make payment of Arrear Provisional Assessment Bill of Rs.15,367/- by four (4) installments commencing on and from October - 2023 and the first installment of Rs.3,367/- must be paid by first week of October, 2023 to the Electricity Department and other three installments of Rs.4000/- each should be paid by consecutive three months and filing money receipt before the court, i.d to J/C till 07.10.2023. If on bail to date (07.10.2023) for appearance and filing money receipt.

Let a copy of this order be sent to the concerned CCC, Electricity Department for information.

Let a copy of this order be supplied to the accused free of cost for making payment to the Electricity Department at once.
