CCL is not produced today from Korok Home, Jalpaiguri as per RT message filed received from Korok Home, Jalpaiguri on the ground stated therein.

Perused the same. Let it be kept with the record.

No CD and Situation Report are received from I.O as per RT message received from him on the ground stated therein.

Ld. P.P. is present. No members are present due to dissolution of earlier Board on 19.10.2025.

Maternal Uncle/Zimmadar is present today to take the custody of the CCL as a fit person.

Ld. Advocate files a bail petition along with fresh vokalathanama by his guardian/maternal uncle on behalf of the CCL.

Ld. Defence Advocate submits before the Board that there is no bail application filed in respect of the CCL before the Hon'ble Apex Court not there is any rejection of bail application in respect of the CCL by the Hon'ble Apex Court. Thus the Ld. Advocate for the CCL prays for bail on any terms and condition.

Heard submission of Ld. Advocate for the CCL as well as the Ld. PP-in-charge.

Ld. PP-in-charge raised objection.

Record is taken up for pass necessary order as regards bail application.

Maternal Uncle/guardian is present before Ld. Principal Magistrate and he stated that he is ready to take custody of the CCL as a fit person and undertakes to ensure his safety, security & welfare.

I have scrutinized the record and considered all submissions.

Considering all aspects and his voluntariness, I am of view that the safety, security & welfare of above mentioned CCL shall be ensured if he is placed in the protective custody of his guardian/mother.

As such bail prayer of the CCL stands allowed on A.I basis.

Maternal Uncle/guardian of aboved mentioned CCL is declared fit person and the custody of CCL is entrusted upon her, if not wanted in any other case.

Maternal Uncle/guardian shall furnish A.I bail bond of Rs. 1000/- upon condition to ensure safety, security and welfare of the CCL at all times and to appear on all dates during inquiry, not to leave jurisdiction of this Board until further order, not to contact with the victim or their family or visit their house I/d to protective custody in observation home.

Call for I.O's Report along with C/C of CD in c/w this case on next date fixed positively.

Let a copy of this order be sent to I.O through O/C of Sitalkuchi PS for his information and compliance.
