Today is fixed for production of the CCL, counselling report from the CCI, SIR, CD and situation report from I.O.

Persued the same. Let the same be kept with the record.

Counselling report is received from the CCI. Let the same be kept with the record.

No SIR is received in respect of the CCL.

Issue strong reminder regarding the same at once.

CD is recived from the I.O. along with Situation Report,

CCL is produced before this Board with proper escort from the Korok Home, Jalpaiguri with proper escort. He is taken into safe custody.

Ld. PP-in-charge is present.

Ld. Advocate files a bail petition on behalf of the CCL through his guardian/father.

Counselling is done by the Counselor of this board and report to that effect has been filed.

Let the same be kept with the record.

We have interacted with the CCL at length and scrutinized the record and considered all submissions.

Now the record is taken up for hearing of bail petition.

Heard both sides Ld Counsel. Ld. PP raised strong objection.

Perused the situation report.

We have interacted with the father of the CCL, who is present before the Board today. He stated that he has a salon and works there the whole day. The mother of the CCL has eloped with someone. He has only one son i.e the CCL. The CCL has left his school during covid times and he roams around with the boys of his locality the whole day.

Heard and Considered.

Perused the CD and the materials available in the CD, especially the situation report of the area where he resides.

Considering all aspects and keeping in mind the welfare of the CCL, release of the CCL at the moment is likely to bring the CCL into association with any known criminal or expose him to moral, physical or psychological danger and the release of the CCL will defeat the end of justice. Moreover this Board finds that the proper counselling of the CCL is required.

Hence, the CCL is remanded to protective custody at Observation Home for safety, security and welfare and also rendered psychological counseling.

As such prayer for bail is rejected at this stage.

The CCL is remanded to protective custody in Observation Home.

The Superintendent, Korok Home Jalpaiguri is directed to make necessary arrangement for regular counselling of the CCL while in protective custody and forward all reports on the next date fixed positively.

GRO, JJB is directed to make necessary arrangment to produce the CCL before Superintendent, Korok Home, Jalpaiguri with proper escort, safety & security.

The escort team is directed to take care regarding the safety & security of the CCL during his transit to Korok Home, Jalpaiguri.

The Superintendent, Korok Home Jalpaiguri is further directed to ensure safety, security of the CCL during his stay at the Korok Home, Jalpaiguri.

Let a copy of this order be served upon the Superintendent, Korok Home Jalpaiguri at once.

Call for further CD along with fresh situation report.

Let a copy of this order be served upon the I.O. through the I/C of Kotwali PS, Cooch Behar at once.

G.R.O of this board is also directed to inform the I.O. at once.

CD be returned today.
