The substance of the accusation u/s-351(2)/126(2)/117(2)/329(4)/109/3(5) of BNS is read over to the CCL in bengali language to the effect that “on 10.05.2025 at about 19:00 hrs, you and your associates went in front of the complainant’s house and abused him. When the complainant raised objection, at that time you and your associates assaulted him with bamboo sticks. As a result, he sustained injury and admitted to Dinhata SD Hospital for treatment. Later on 12.05.2025, the complainant was discharged from the hospital and returned to his house. Thereafter, on 13.05.2025 at about 00:00/00:30 hrs, you and your associates wrongfully entered into the house of the complainant. When the complainant and her daughter came out their bedroom, at that time you pressed the throat of the complainant’s daughter with an intention to kill her and assaulted her too” to which she pleaded not guilty by saying “aami nirdosh” and claims to be tried as per law.

Issue fresh summon upon CSW-1.
