Received one split-up case record from Ld. CJM, Cooch Behar in c/w above mentioned case reference along with order sheet, C/C of Formal FIR, C/C of Written Complaint and other relevant documents.

Both the CCLs are surrendered today in compliance of order No:04 dated 16.03.2026 passed by Ld. CJM, Cooch Behar.

They are taken into safe custody.

Perused the case record and the date of birth of both the CCLs, it appears that the date of birth of the CCL No-1 is on 11-05-2009, the date of birth of the CCL No-2 is on 09-05-2010 and the date of offence is on 24-02-2026 which suggests that they were 16 years, 09 months 13 days and 15 years 9 months and 15 days old respectively on the date of incident.

The case is received and registered in the trial register.

Zimmaradar/mother of the CCL No-1 and Zimmaradar/grandfather of the CCL No-2 are present today to take custody of the CCLs.

Ld. PP-in-charge is present. No members are present due to dissolution of earlier Board on 19.10.2025.

Ld. Regular P.O of this Board has deployed in SIR duty. I'm in charge of this Board today.

Ld. Advocate for the CCLs files a bail petition along with fresh vokalathnama by their guardian/zimmaradar on behalf of the CCLs and prays for bail on any terms and condition.

Now the record is taken up for bail hearing.

Heard submission of Ld. Advocate for the CCL as well as the Ld. PP-in-charge.

Ld. PP-in-Charge raised objection.

I have Scrutinized the record, considered all submissions.

Zimmaradar/guardian of the CCLs submit that they are ready to take custody of the CCLs as fit persons and undertake to ensure their safety and security.

Considering all aspects as well as the safety, security & welfare of above mentioned CCLs shall be ensured if they are placed in the protective custody of their guardian/zimmaradar.

As such bail prayer of the CCL stands allowed on A.I basis.

Zimmaradar/guardian of aboved mentioned CCLs are declared fit persons and the custody of CCLs are entrusted upon them, if not wanted in any other case.

Zimmadar/guardian of the CCLa shall furnish A.I bail guardian bail bond of Rs. 1000/- each upon condition to ensure safety, security and welfare of the CCLs at all times; CCLs are directed not to enter into the local area of the victim or not

enter into the Place of occurrence, not to contact in any fashion the family of the victim or visit their house, ensure not to make any association with bad character persons or para people or to any person acquainted with the facts of the to dissuade him from disclosing to the case so as such fact to the Board or Investigating Officer/any Police Officer.

Call for C/C of CD along with I.O's Report from the concern PS.

Let a copy of this order be sent to O/C of Sadar women PS for his information and taking necessary action.

Call for Social Investigation Report from Probation Officer, Cooch Behar within 15 days from date of issue.

Call for Social Background Report from C.W.P.O of Sadar Women PS.

Let a copy of this order be sent to C.W.P.O of Sadar Women PS through O/C of Sadar women PS for his information and taking necessary action.

D.A to comply.

If on bail, fix **10-04-2026** for appearance of both the CCLs who are on A/I bail, SIR, SBR & C/C of CD from the concern PS.

Grandfather/Guardian namely Mona Khan of the CCL No-2 namely Soheli Khan and Mother/Guardian namely Jaheda Khatun of the CCL No-1 namely Raju Miah furnished A.I bail guardian bond of Rs. 1000/- each on behalf of the CCLs which are found fit, correct and accepted.

Release the CCLs at once if not wanted any other case.
