ORDER BELOW EXH.1

01. This is an application filed U/s. 2 of The Bombay Regulations 1827 for issuance of Legal Heirship Certificate.

02. The applicants submitted that they are legal heirs of deceased **Haridas Laxman Tupe**. He died on 11.02.2026. at Cooper Municipal Hospital, West Mumbai. Applicant no.1 is wife, applicant no.2 and 4 are sons and applicant no.3 is daughter, applicant no.5 is mother of deceased Haridas Laxman Tupe.

03. The applicants submitted that, they are legal heirs of deceased Haridas Laxman Tupe. The applicants needs Heirship Certificate for official purpose. Hence, this application.

04. The notice of this application was proclaimed in the news paper “Beed Kisan” calling objection if any on the application. The said notice is filed at **Exh-10**. No objection is raised to the application.

05. The applicant no.1 filed supporting affidavit at **Exh-5** and Evidence affidavits at **Exh-11**. The applicants filed on record original Death Certificate of Haridas Laxman Tupe (**Exh-6**) and Aadhar Cards of applicants are also placed on record. The applicants closed evidence vide pursis **Exh-12**.

06. Heard Ld. Advocate D. C. Giram for the applicants. Perused the application and the record.

07. The supporting affidavit at **Exh-5** and Evidence affidavit at **Exh-11** proves that the applicants needs Heirship Certificate for official purpose. The Death Certificate (**Exh.6**) proves that Haridas Laxman Tupe died on 11.02.2026.

08. The evidence on record proves that, applicants are legal heirs of deceased Haridas Laxman Tupe. Hence, applicants are entitled to get Heirship Certificate. Resultantly, I proceed to pass the following order;

ORDER

A.	Application is allowed.
B.	Legal Heirship Certificate be issued in the form prescribed in Bombay Regulations 1827 in favour of applicants nos. 1. Gitanjali Haridas Tupe 2. Vedant Haridas Tupe 3. Vaishnavi Haridas Tupe 4. Wishavjit Haridas Tupe 5. Suman Lakshman Tupe certifying that they are Legal Heirs of deceased Haridas Laxman Tupe .
C.	The certificate shall be issued after payment of requisite Court Fee Stamps by applicants.
