This is an application vide Section II of Bombay Regulation Act for issuance of Heir-ship certificate.

2) Brief facts which constrained the applicants to file the present application can be seen as under;

The applicant No. 1 is husband, applicant Nos. 2 to 4 are sons and applicant nos. 5 and 6 are married daughters of deceased **Kamalbai Raghunath Yadav** who died on **01/12/2021**. The applicants are the only legal heirs of deceased **Kamalbai Raghunath Yadav**. She has no other legal heirs except the present applicants. The present applicants required heirship certificate for governmental as well as semi governmental use. This Court has jurisdiction to issue such certificate. Hence, prayed to allow the application.

3) After filing of the petition, citation was issued in the newspaper. Thereafter, no one appeared in response to the same.

4) The applicants have relied upon certified copy of death certificate of deceased **Kamalbai Raghunath Yadav** at Exh.12, copies of Aadhar cards of applicants at Exh.13 to 18 and copy of newspaper at Exh.10. The applicant has filed his evidence on oath at Exh.11.

5) It is the contention of applicants that they are legal heirs of deceased **Kamalbai Raghunath Yadav** who died on **01/12/2021**. The

death certificate of deceased **Kamalbai Raghunath Yadav** shows that he died on 01/12/2021. Thus, the contentions in the application regarding the date of death seems to be correct. Moreover, the applicant has examined himself and reiterated the contents of the application. It can be noted that no one has registered objection in response to the paper publication denying the relation of applicants with deceased **Kamalbai Raghunath Yadav**. Believing upon this evidence, it can be safely hold that the applicants are recognized formally as legal heirs of deceased **Kamalbai Raghunath Yadav**. Upshot of the discussion is that heirship certificate in favour of applicants can be issued. Hence, following order.

ORDER

Issue heirship certificate in the name of applicants No.
1 to 6 in respect of deceased **Kamalbai Raghunath
Yadav** on payment of requisite Court fees.
