The Reference petition is filed under Section 64 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (hereinafter referred as 'Act'), being aggrieved by the award passed in LAQ: SR: No.23/2017-18 dated: 18.09.2019 in respect of acquired irrigated land bearing Sy.No.379/2A, 379/2B, (379/2JMC) measuring 1 acre 6 guntas, situated at Siddapur K village for enhancement of compensation as per provision of Section 64 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

This petition is coming on **19th day of December-2025** before **SRI.H.A.MOHAN, B.A.L., LL.B., I Addl. District Judge & The Land Acquisition, Rehabilitation and Resettlement Authority, Vijayapura**, in the presence of **Sri.M.B.Aladi**, Advocate for Claimants/Petitioners, **Addl. District Government Pleader** for the Respondent No.1 & 3, and **Sri.M.G.Pattahashettti**, Advocate for Respondent No.2.

It is Ordered and Awarded that -

The reference petition filed under Section 64 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 by the petitioners is hereby partly allowed with costs.

The petitioners in respect of the acquired irrigated land bearing Sy.No.379/2A, 379/2B, (379/2) measuring 1 acre 6 guntas, situated at Siddapur K village are entitled for compensation at the rate of Rs. 1,937/- per square meter.

Further, the claimants are entitled for 100% solatium on market value redetermined U/Sec. 26 of the Act, as provided U/Sec.30(1) and First Schedule of RFCTLARR Act 2013.

Further, in addition to market value as redetermined U/Sec.30(3) of the Act the petitioners are also entitled for additional compensation at the rate of 12% per annum on such market value from the date of publication of the notification of the Social impact Assessment Study till the date of the award of the Collector i.e. from 19.10.2017 till 18.9.2019, as provided U/sec.30(3) of RFCTLARR Act 2013.

The petitioners are also entitled for interest at the rate of 9% per annum on excess/enhanced compensation for a period of one year from the date of dispossession and thereafter, at the rate of 15% per annum for the subsequent period till the date of deposit of enhanced compensation, as provided under Section 72 and 80 of the RFCTLARR Act 2013.

Further, the respondents are entitled to deduct the interest if any, for the period ordered by the Court during the course of proceedings.

The amount, if any, already paid to the claimants, shall be deducted from the total compensation amount, excluding the amount paid towards buildings and trees.
