If no settlement is reached, neither the parties, the Ld. Advocates, nor the Ld. Mediator may disclose to this Court anything that was discussed at the mediation.

Having regard to the nature of the case, the fees of the Ld. Mediator be fixed at a consolidated amount of **Rs.2000/-** in terms of Rule 26/26A(2) of the existing Mediation Rules, as amended, on settlement of the case through mediation.
