I find that NIA has re-registered a case being no. RC-4/2026/NIA/DLI dated 30.01.2026 under section 9 of the West Bengal Maintenance of Public Order Act, 1972, under section 8B of the National Highway Act, 1956, under section 109/115(2)/117(2)/121(1)/121(2)/126(2)/132/189(2)/189(4)/221/324(5) of the Bharatiya Nyaya Sanhita, 2023, 3 & 4 of the Prevention of Damage to Public Property Act, 1984 and 16(1)(b) of the UA(P) Act, 1967 against 36 accused persons namely as follows :-

Accordingly, register the case as NIA Special Case.

Today I.O has filed one petition through the Id. Special P.P., NIA of the instant case with prayer to pass necessary order

1) to allow the NIA for filing copy of re-registered FIR of NIA case no. RC-4/2026/NIA/DLI,

2) to take cognizance of the re-registered NIA FIR

3) to direct the Superintendent of Police, Murshidabad, West Bengal to instruct the concerned I.O. of the Beldanga Police Station case No. 51/2026 dated 17.01.2026 to hand over the original case records, with all exhibits, material objects, documents, alamats, all the relied/non-relied upon evidence(s). i.e. documentary, expert opinion(s), technical electronic and statements of witnesses etc. to the CIO of NIA of this case being no. RC-4/2026/NIA/DLI.

4) to direct the concerned I.O. of the Beldanga Police Station case No. 51/2026 dated 17.01.2026 to hand over the original case records, with all exhibits, material objects, documents, alamats, all the relied/non-relied upon evidence(s). i.e.

documentary, expert opinion(s), technical electronic and statements of witnesses etc. to the CIO of NIA of this case being no. RC-4/2026/NIA/DLI.

5) to direct the Ld. Chief Judicial Magistrate Court, Behrampur Court for P.C Beldanga to at once transmit the original case recors of Beldanga Police Station case No. 51/2026 dated 17.01.2026 before this Court.

6) to direct the Superintendent of Jail, Murshidabad, West Bengal to immediately produce all the arrested accused persons in connection with Beldanga Police Station case No. 51/2026 dated 17.01.2026 before this Court and

7) to further direct the concerned I.O to produce the arrested accused persons (if in police custody) before this Court on the date fixed as the Government of India, Ministry of Home Affairs, CTCR Division, North Block, New Delhi as per order bearing no. 11011/16/2026/NIA dated 28.01.2026 has ordered that the case being investigated by the NIA and also prays for passing order for production of the aforesaid accused persons before this court.

Ld. Special Public Prosecutor of NIA, Shyamal Ghosh moves the petition.

Heard the Special Public Prosecutor of NIA,

Perused the petition, photocopy of FIR and the notification of Govt. of India, Ministry of Home Affairs and relevant documents.

Considering the entire facts and circumstances, the petition filed by the Special Public Prosecutor of NIA is allowed for the ends of justice.

Ld. District and Sessions Judge, Murshidabad, West Bengal is requested to instruct the Ld. Chief Judicial Magistrate, Behampur to transfer the original judicial record in connection with Beldanga Police Station case No. 51/2026 dated 17.01.2026 before the court of ld. Chief Judge, City Sessions Court, Calcutta, Bichar Bhawan, 2 & 3, Bankshall Street, Kolkata- 700 001 which is the special Court designated to try the offences under the NIA Act.

The Superintendent of Police, Murshidabad, West Bengal and the I.O. of Beldanga Police Station case No. 51/2026 dated 17.01.2026 are directed to hand over all the original case diaries, material objects and articles seized in connection with this case along with expert opinion(s), technical, electronic and statements of witnesses etc. to the I.O. of NIA appointed to investigate the instant case in the meantime positively.

The I.O is directed to submit the original re-registered FIR being no. RC-4/2026/NIA/DLI dated 30.01.2026 along with the original Government order bearing no. 11011/16/2026/NIA dated 28.01.2026.

Let a copy of this order along with a letter of request be forwarded to the Ld. District and Sessions Judge, Murshidabad, West Bengal for information and giving necessary direction to the Ld. Chief Judicial Magistrate, Behampur to take necessary

step for production of the aforesaid 36 accused persons before the Id. Chief Judge (Special Court, NIA), City Sessions Court, Calcutta on the next date i.e. **26.02.2026**.

Let a copy of this order be sent to the Superintendent of Police, Murshidabad, West Bengal to instruct the concerned I.O. of the Beldanga Police Station case No. 51/2026 dated 17.01.2026 for necessary compliance.

Let a copy of this order also be given to the Ld. Special Public Prosecutor of NIA, Shyamal Ghosh so that he may process the matter keeping in mind the exigency of the instant case.

Let a copy of this order be sent to the I.O. of Beldanga Police Station case No. 51/2026 dated 17.01.2026 for necessary compliance.

Let a copy of this order be also given to the I.O., NIA as prayed for.
