1. Ld. PO has been retained on duty in the courts during the upcoming process of Special Intensive Revision (S.I.R.) by the Hon'ble Court, Calcutta in view of the order dated 20.02.2026 passed by the Hon'ble Supreme Court of India in Writ petition(s) Civil Number(s)1089 of 2025 with W.P. (C) Number-126/2026, W.P. (C) Number-129/2026(PIL-W), W.P. (C) Number-737/2025(PIL-W), W.P. (C) Number-1074/2025 (PIL-W), W.P.(C) Number-1088/2025 (PIL-W), W.P.(C) Number-1216/2025(PIL-W), W.P.(C) Number-159/2026(PIL-W), W.P.(C)Number-119/2026 (PIL-W). I am in charge.
2. Today is fixed for production of the seven accused persons, namely, 1) Md. Wazed Ali Molla, S/o late Mahasin Molla, 2) Salauddin Sk, S/o Abu Bakkar Sk, 14) Rayajul Hoque, S/o Ekramul Hoque, 20) Nasir Sk, S/o Nibastullah Sk, 27) Milan Sk, S/o late Swapan Sk, 29) Motiur Rahman, S/o late Md. Kawsarul Hoque and 34) Ladim Sk, S/o Moulabox Sk, before this court from the custody of NIA, submission of report by the NIA and hearing of the three bail applications dated 02.03.2026 filed on behalf of the accused persons and written objections, if any, in the meantime.
3. The accused persons, namely, **1) Md. Wazed Ali Molla, S/o late Mahasin Molla, 2) Salauddin Sk, S/o Abu Bakkar Sk,14) Rayajul Hoque, S/o Ekramul Hoque, 20) Nasir Sk, S/o Nibastullah Sk, 27) Milan Sk, S/o late Swapan Sk, 29) Motiur Rahman, S/o late Md. Kawsarul Hoque and 34) Ladim Sk, S/o Moulabox Sk**, are produced before this Court from the custody of NIA along with medical slips and they are taken into custody.
4. Ld. Special Public Prosecutor representing the National Investigation Agency is present.
5. Ld. Advocates for the accused persons are present.
6. Dy. SP/CIO, NIA, B.O. Kolkata files a petition through the Ld. Special Public Prosecutor praying for 14 days Judicial custody of the seven accused persons namely, 1) Md. Wazed Ali Molla, S/o late Mahasin Molla, 2) Salauddin Sk, S/o Abu Bakkar Sk, 14) Rayajul Hoque, S/o Ekramul Hoque, 20) Nasir Sk, S/o Nibastullah Sk, 27) Milan Sk, S/o late Swapan Sk, 29) Motiur Rahman, S/o late Md. Kawsarul Hoque and 34) Ladim Sk, S/o Moulabox Sk, for the purpose of through and proper investigation of this case.
7. Ld. Special Public Prosecutor representing the National Investigation Agency draws the attention of this Court to the petition filed Dy. SP/CIO, NIA, B.O. Kolkata in para 20 which runs as follows -

“ That, in compliance of your kind order dated 17.02.2026 and subsequent order passed by the Hon’ble Calcutta High Court I/O of Beldanga P.S has handed over the case diary and connected material(s)”.

8. Now, the prayer for judicial custody of the seven accused persons is taken up for hearing.
9. Heard. Considered. The prayer for judicial custody of the seven accused persons, namely, 1) Md. Wazed Ali Molla, S/o late Mahasin Molla, 2) Salauddin Sk, S/o Abu Bakkar Sk, 14) Rayajul Hoque, S/o Ekramul Hoque, 20) Nasir Sk, S/o Nibastullah Sk, 27) Milan Sk, S/o late Swapan Sk, 29) Motiur Rahman, S/o late Md. Kawsarul Hoque and 34) Ladim Sk, S/o Moulabox Sk, is **allowed** for the purpose of through and proper investigation of this case.
10. Issue custody warrant accordingly.
11. The seven accused persons, namely, **1) Md. Wazed Ali Molla, S/o late Mahasin Molla, 2) Salauddin Sk, S/o Abu Bakkar Sk, 14) Rayajul Hoque, S/o Ekramul Hoque, 20) Nasir Sk, S/o Nibastullah Sk, 27) Milan Sk, S/o late Swapan Sk, 29) Motiur Rahman, S/o late Md. Kawsarul Hoque and 34) Ladim Sk, S/o Moulabox Sk** be remanded to J.C till **13.03.2026**.
12. Separate written objection against the bail petitions of accused persons Samayun Sk, Injamul Hoque, Abdul Motalim, Muluk chand, Mursalim Sk, Najmul Hoque, Hadisul Hoque, Mofijul Sk, Hodleb Molla, Washim Sk, Fajlur Rahaman, Nur Alam, Modasir Sk, Raja Sk, Md. Ali Murtaja, Janarul Sk, Anower Sk and Atibur Sk have been filed by the National Investigation Agency.
13. Copy served.
14. Perused. Let the same be kept with the record.
15. Ld. Advocates for the accused persons file a petition praying for physical production of the accused persons before this Court on the next date of hearing.
16. Heard. Considered. The prayer is allowed.
17. The Superintendent of Presidency Correctional Home is directed to produce the accused persons physically before this Court on the date fixed positively.
18. Todate, i.e., on **13.03.2026**, for production of the accused persons and hearing of the bail petitions.
19. Let a copy of this order be sent to the Superintendent, Presidency Correctional Home for information and necessary compliance.
20. Let a copy of this order be sent to the Investigating Officer through the Ld. Special Public Prosecutor for National Investigation Agency for information.
