1. Today is slated for production of the accused persons in connection with NIA case no. RC-04/2026/NIA/DLI.
2. Accused persons are not produced.
3. The Superintendent, Berhampore Central Correctional Home has submitted non-production report in respect of thirty one under trials before this court today.
4. Ld. Special Public Prosecutor representing the National Investigation Agency is present.
5. Fresh vakalatnama has been filed on behalf of the accused persons, namely, Najibur Rahaman, Sadikul Sk, Moharam Sk and Akul Chand. Perused the same and let it be kept with the record.
6. Ld. Advocates for the accused persons are present.
7. One petition is filed on behalf of the accused Salauddin Sk. Perused the same and let it be kept with the record.
8. Mr. Saroj Bhattacharjee, Dy. SP/CIO, NIA, B.O., Kolkata, has filed an application, in connection with NIA case no. RC-04/2026/NIA/DLI, with an allegation that Investigation Officer of Beldanga Police Station, in connection with Beldanga PS case no. 51 of 2026 dated 17.01.2026, has not handed over alams and connected materials to the Chief Investigating Officer, NIA.
9. The Superintendent, Berhampore Central Correctional Home has submitted report to the effect that he has failed to produce the accused persons in this court as no escort and Police Guard has been provided by the local police administration. In such circumstances, a report is required to get at the truth.
10. The Superintendent of Police, Murshidabad is directed to submit a report personally in details as regards the allegations made by Mr. Saroj Bhattacharjee, Dy. SP/CIO, NIA, B.O., Kolkata vide his application dated 05.02.2026.
11. The Superintendent, Berhampore Central Correctional Home is directed to produce the accused persons before this court by 12.02.2026 positively.
12. The Superintendent of Police, Murshidabad is directed to provide police escort for production of the accused persons before this court on the date fixed.
13. The Investigating Officer of Beldanga Police Station, in connection with Beldanga PS case no. 51 of 2026 dated 17.01.2026, is directed to appear personally before this court on the next date fixed to explain as to why the order passed by this court on 30.01.2026 has not been complied with. He is also directed to submit his written explanation in this regard.
14. The Officer in Charge, Beldanga PS is directed to convey this order to the Investigating Officer of Beldanga Police Station case no. 51 of 2026 dated 17.01.2026 for compliance.

15. Todate, i.e., **12.02.2026**, for production of the accused persons, personal appearance of the Investigating Officer of Beldanga PS and submission of report by the Superintendent of Police, Murshidabad.
16. Let a copy of this order be sent to the Superintendent of Police, Murshidabad for submission of report and compliance.
17. Let a copy of this order be sent to the Superintendent, Berhampore Central Correctional Home for information and production of the accused persons.
18. Let a copy of this order be sent to the Officer in Charge, Beldanga PS for information and necessary compliance.
