

SESSIONS CASE NO.128 OF 2013.

Order No. 31 dated 16 .8.14.

Out of 09 accused persons on bail 04 accused persons namely (1) Dipen Malley (2) Babita Ganguli @ Satong (3) Sunil Rai and (4) Ashish Tamang are present by filing hazira while 05 accused persons namely (5) Sudesh Rai Majhi ,(6) Prashant Chettri @ Yogen Rai , (7) Subash Tamang (8) Puran Rai and (9) Tilak Rai are absent by a petition and represented by their Advocate under section 317 Cr.P.C which is allowed.

18 accused persons namely 1) Kamal Sinha, 2) Pravin Subba, 3) Sanjoy Tamang, 4) Naresh Rai, 5) Suraj Singh, 6) Arun Moktan @ Tamang, 7) Amol Lama, 8) Sona Sherpa, 9) Dawa Sange Sherpa, 10) Nagendra Pradhan @ Nagen, 11) Keshar Rai, 12) Bhanu Rai, 13) Alok Kanta Mani Thulung @ Rai, 14) Kismat Chettri, 15) Puran Thami, 16) Tenzing Khambachey, 17) Keshab Raj Pokhrel and 18) Dinesh Gurung @ Karate Kaila are produced from J.C.

Ld. Advocate for the accused persons as well as Ld. Special P.P representing the prosecution/ C.B.I are present.

One hazira is filed on behalf of the widow of the deceased.

Comprehensive report has not yet been submitted .

Ld. Special P.P submits that investigation is still under progress and the comprehension report will be submitted very soon and he also submits that prosecution has already moved the Hon'ble Apex Court for getting the time extended for submission of comprehension report.

Under the circumstances, case is adjourned.

All the accused persons in custody are remanded to J.C till 30.8.14.
