To-date is also fixed for compliance report from the Investigating Officer, CBI as directed vide order no.189 dated 27.08.2024 passed by this Court.

Ld. Counsel for the De-facto Complainant and Ld. Special P.P. for C.B.I. are present.

Ld. Counsel for the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Crime Investigation Department, Government of West Bengal is present by filing a photocopy of appointment letter issued by the Ld. Legal Remembrancer, Govt. of West Bengal vide Memo no.7682-A/Misc.26/2026 (CrI.) dated 09.09.2024.

Let the same be kept with the record.

The Inspector, CBI, SCB, Kolkata (Holding Investigating Officer) files one compliance report through the Ld. Special P.P. in terms of order dated 27.08.2024 passed by this Court.

In the report the I.O. of this case stated inter alia that the seized mobile phones and SIM cards along with one Micro SD Card contained in one of the mobiles were sent to CFSL, New Delhi vide letter dated 17.06.2011 for forensic examination, retrieval of data and expert opinion and the said mobile phone has been cited in the list of material objects as Annexure-III in the Supplementary Charge Sheet No.04 dated 20.08.2011 filed by CBI and subsequently, CFSL, New Delhi forwarded the forensic expert report dated 13.09.2012 on the said mobile phones, SIM Cards and SD Cards to the Sr. SP CBI SCB Kolkata.

Perused the same and let the same be kept with the record.

No compliance report has yet been received from the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Crime Investigation Department, Government of West Bengal in terms of order no.189 dated 27.08.2024 passed by this Court.

Ld. Counsel for the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Crime Investigation Department, Government of West Bengal files a petition stating that the order dated 27.08.2024 of this Court was served upon the Inspector General, Intelligence Branch, West Bengal and the ADG (Crime) CID, West Bengal on 04<sup>th</sup> September, 2024 and during this short period which included the weekend, the I.B. and C.I.D. have been in difficulty to trace out the relevant documents, if any, to apprise the fact to this Court and therefore a short time preferably till 17.09.2024 has been prayed for.

Heard all sides on the point of adjournment.

Prayer for an adjournment is considered and allowed for the ends of justice with a direction upon the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Crime Investigation Department, Government of West Bengal to submit a report before this Court in terms of order no.189 dated 27.08.2024 passed by this Court on the next date fixed positively.

On consent of all sides, fix **17.09.2024** for submission of compliance report by the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Crime Investigation Department, Government of West Bengal in terms of order no.189 dated 27.08.2024 passed by this Court.

To-date i.e. on 20.09.2024 for appearance and framing of charge.

To-date i.e. on 20.09.2024 for bringing order from the Hon'ble Supreme Court of India.

Let a copy of this order be sent to the Inspector General of Police, Intelligence Branch, West Bengal for information and necessary action.
