Order no.204 dated 12.03.2025

Today is fixed for further hearing upon the petition dated 26.07.2024 filed by the victim party and submission of reports by the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal and the CBI.

Ld. Counsel for the De-facto Complainant/ victim party is present in virtual mode.

Ld. Special P.P. for C.B.I. is present.

Ld. Counsel for the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal is also present.

One compliance report has been filed on behalf of the C.B.I. in terms of order no.202 dated 20.02.2025 passed by this Court.

Perused the same and let the same be kept with the record.

No compliance report in terms of order no.202 dated 20.02.2025 passed by this Court has yet been submitted on behalf of the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal.

Ld. Counsel for the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal files one petition stating that during the course of the hearing, the Ld. Counsel for the Victim Party referred to various documents including the application dated 26.07.2024, the charge sheet filed by the CBI including the annexures and various orders passed by the Hon'ble Supreme Court of India from time to time in connection with this case, but the copies of those documents, petitions and the orders of the Hon'ble Court were not supplied to the petitioner herein.

Ld. Counsel further stated that without perusing those documents it is becoming extremely difficult for the petitioner/ Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal to assist this Court by providing the clarifications as sought for and therefore the Ld. Counsel prays for a direction upon the other parties to supply copies of the documents which are as follows for submitting the report as sought by this Court

(a) Copy of the application dated 26.07.2024 filed by the victim along with various documents relied upon by the victim party at the time of hearing.

(b) Copy of the charge sheet filed by the Central Bureau of Investigation including all the documents relied upon by the Investigating officer as well as the documents not relied upon.

(c) Copies of the relevant orders passed by the Hon'ble Supreme Court of India which are being relied upon by the victim party.

Ld. Counsel for the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal further submits that without those copies the petitioner is unable to file the report in compliance with the order no.202 dated 20.02.2025 passed by this Court and also prays for some more time to file compliance report.

Ld. Counsel for the victim party submits that he is ready to supply copy of the petition dated 26.07.2027 filed by the victim party/Defacto complainant as well as Copies of the relevant orders passed by the Hon'ble Supreme Court of India in connection with this case.

Ld. Special for the C.B.I. submits that Prosecution is ready to supply copies of the charge sheet filed by the Central Bureau of Investigation including all the documents, but it will take some time as the copies are voluminous in nature.

Heard both sides.

Having heard the submissions of all sides and also on consideration of the rival submissions of the respective parties the Ld. Counsel for the victim party and Ld. Special for the C.B.I. assuring this Court that they will submit the copies of the documents as sought for by the Ld. Counsel for the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal and this Court directed the Ld. Counsel for the victim party to serve copies of the petition dated 26.07.2027 filed by the victim party/Defacto complainant as well as Copies of the relevant orders passed by the Hon'ble Supreme Court of India at once and file an acknowledgement receipt in this regard.

Ld. Special P.P. for the C.B.I. is also directed to instruct the I.O. of this case to take necessary steps to serve copies of the charge sheet filed by the Central Bureau of Investigation including list of all the relied upon and non relied upon documents at once and file an acknowledgement receipt in this regard on the next date fixed.

The Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal shall submit the report as directed by this Court by its order no.202 dated 20.02.2025. I also find that the CBI has already filed the report in compliance to the order passed by this Court on 20.02.2025.

Let a copy of the instant order along with the copy of order dated 20.02.2025 be served upon the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime) for immediate compliance.

To-date i.e. **25.03.2025** for further hearing upon the petition dated 26.07.2024 filed by the victim party and submission of reports by the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal.

To-date i.e. on **25.03.2025** for filing acknowledgment receipt with regard to service of copies of documents to the petitioner/ Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal and also to the Ld. Counsel for the victim party and the Prosecution.

To-date i.e. on 25.03.2025 for production of the accused person namely Puran Rai @ Puran Bahadur Rai, appearance of rest of the accused persons and framing of charge.

To-date i.e. on **25.03.2025** for bringing updated order from the Hon'ble Supreme Court of India, if any.

To-date i.e. on **25.03.2025** for E.R. of Warrant of Arrest against the accused person, Pradeep Pradhan.

Let a copy of this order be sent to the I.O. of this case through the Ld. Special P.P. for information and necessary action.

Let a copy of this order be sent to the Inspector General of Police, Intelligence Branch, West Bengal and the ADG (Crime), Criminal Investigation Department, Government of West Bengal for information and necessary action.
