1. Ld. 3. Accused Anant Kumar Agarwal is produced from the J/C before this Court through audio-video electronic means.

4. Accused Sanjay Kumar Surekha is produced from the J/C before this Court in physical mode.

5. Ld. Special Public Prosecutor for the Enforcement Directorate is present.

6. Two separate written objections have been filed on behalf of the Complainant/ Enforcement Directorate.

7. Copy of written objection has been served upon the Ld. Counsel for the accused person namely Sanjay Kumar Surekha.

8. None turns up on behalf of the accused person namely Anant Kumar Agarwal.

9. No step is taken on behalf of the accused person namely Anant Kumar Agarwal.

10. Today Ld. Lawyers did not attend the Court proceedings due to resolution taken by the local Bar on account of death of a Ld. Advocate.

11. In view of the above fact, the case is adjourned today for the ends of justice.

15. The Superintendent, Presidency Correctional Home is directed to produce this accused person Sanjay Kumar Surekha before this Court on the date fixed physically.

16. To date i.e. on 07.03.2026 for production of the accused persons Anant Kumar Agarwal and Sanjoy Kumar Surekha.

17. The accused persons Anant Kumar Agarwal and Sanjoy Kumar Surekha be remanded to J.C till 07.03.2026.

18. To-date i.e. on 07.03.2026 for hearing of the petition u/s 346 of the BNSS, 2023 filed by accused Anil Kr. Jain, hearing of the petition dated 18.09.2025 filed by the proposed accused persons A-2, A-8, A-11 and A-17, hearing of the petition dated 16.12.2025 filed by the proposed accused Suresh Kr. Dhandhanian, hearing of the petition dated 31.01.2026 filed by the accused Anant Kr. Agarwal, hearing of the petition dated 13.02.2026 filed by the accused Sanjay Kumar Surekha and written objection, if any, in the meantime.

19. To-date i.e. on 26.02.2026 for appearance of all the proposed accused persons and hearing on the point of cognizance.

20. Let a copy of this order be sent to the Superintendent, Presidency Correctional Home for information and necessary compliance.

21. Let a copy of this order be sent to the Investigating Officer through Ld. Special Public Prosecutor for the Enforcement Directorate for information and compliance.
