Order no. 13 dated 29.06.2026

1. Today is fixed for S/R, production of accused persons and submission of reports.
2. Accused person, namely, namely, Jay S Kamdar and Santanu Sinha Biswas are produced virtually before this Court from J.C.
3. Non-production report of accused Biswajit Podder @ Sona Pappu has been submitted by the Superintendent of Presidency Correctional Home. Let the same be kept with the record.
4. No report in terms of order dated 15.06.2026 passed by this Court is submitted by the Superintendent of Presidency Correctional Home with regard to the medical condition of accused Jay S Kamdar.
5. Ld. Special Public Prosecutors representing the Enforcement Directorate are also present.
6. Ld. Advocates for the accused person are present.
7. Complainant is present by filing hazira.
8. Ld. Advocate for accused Santanu Sinha Biswas files a petition praying for necessary direction upon the jail authorities to comply with the order no. 08 dated 01.06.2026 passed by this Court providing all facilities and amenities to the Division-I prisoner and to submit a report in this regard.
9. Perused. Considered. The Superintendent of Presidency Correctional Home is directed to submit a report in this regard on the next date fixed positively.
10. Ld. Advocate for accused Biswajit Poddar @ Sona Pappu files a petition by stating that this accused/petitioner is suffering from uncontrolled high blood sugar and other diseases and he prays for proper medical treatment of this accused and also prays for calling a report from the concerned Correctional Home in this regard.
11. Heard. Considered. The prayer is allowed.
12. The Superintendent of Presidency Correctional Home is directed to provide proper medical treatment to this accused and submit a report in this regard on the next date fixed positively.
13. Ld. Advocates for accused Jay S Kamdar and Santanu Sinha Biswas filed separate petition praying for their bail. Let those be kept with the record.
14. Ld. Special Public Prosecutor for E.D files a petition praying for filing written objection in this regard.
15. Heard. Considered. The prayer is allowed.
16. Ld. Special Public Prosecutor for ED filed three separate petitions praying for further judicial custody of accused Jay S Kamdar, Santanu Sinha Biswas and Biswajit Podder @ Sona Pappu and to allow the prosecution to record their statement under Section 50 of the Prevention of Money Laundering Act, 2002 in the interest of the on-going investigation.
17. Heard. Perused. Considered. The prayers for judicial custody of the accused persons are allowed for the sake of investigation.
18. Hence, the prayers for judicial custody of accused **Jay S Kamdar, Santanu Sinha Biswas**

and **Biswajit Podder @ Sona Pappu** are **allowed** till **04.07.2026**.

19. Heard. Perused. Considered. The prayer is allowed for the sake of investigation.
20. Accordingly, the Investigating Officer of Enforcement Directorate is at liberty to interrogate and record the statement of the accused Jay S Kamdar, Santanu Sinha Biswas and Biswajit Podder @ Sona Pappu in the correctional home in presence of concerned Jail Superintendent but outside the scope and ambit of their hearing and after compliance of all the legal formalities with regard to interrogation inside the correctional home premises and the same is to be done after proper identification of the team of the Officers of Enforcement Directorate.
21. To **04.07.2026** for production of the accused, hearing of the bail petitions dated 29.06.206 Jay S Kamdar and Santanu Sinha Biswas and **submission of reports with regard to the medical condition of accused Jay S Kamdar, Biswajit Poddar @ Sona Pappu and the jail facilities being received by accused Santanu Sinha Biswas in compliance with the order no. 8 dated 01.06.2026 passed by this Court.**
22. Written objection, if any, in the meantime.
23. The Superintendent, Presidency Correctional Home is directed to produce accused Biswajit Podder @ Sona Pappu on the next date fixed positively.
24. Let a copy of this order be sent to the Superintendent, Presidency Correctional Home for information and compliance.
25. Let a copy of this order also be sent to the Investigating Officer of Enforcement Directorate through the Ld. Special Public Prosecutor for information.
