**Order No.45 dated 20.12.2022**

Today is fixed for further Cross-Examination of P.W.-1, hearing of the Bail application dated 19.12.2022 filed by the Accused no.(A-4) and consideration of the Two letters being letters being nos.12947/AB-I dated 16.12.2022 and 14044/AB-I dated 16.12.2022 regarding production of the accused at Bangalore.

The Accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10) to (A-15) and (A-20) are produced from J.C.

The Accused no.(A-8) is on Court Bail and is present in Court by filing hazira.

One fresh Vakalatnama has been filed on behalf of the Accused no.(A-15)

Ld. Advocates of the accused persons are present in Court.

Ld. Special P.Ps. are also present.

**P.W.-1, Susanta Dhar** is present today. He is Cross-Examined in full on behalf of all the accused persons and **discharged**.

As per Gazette Notification dated 15.07.2022, the certified true copy of the deposition of P.W.-1 dated 20.12.2022 is handed over to both sides i.e. the prosecution as well as the defence Counsels after obtaining endorsement in the relevant register.

Ld. P.P. prays for fixing date for further evidence.

City Civil and Sessions Judge & Special Court for trial of NIA Cases, Bengaluru in connection with SPL CC 128/20, SPL CC 594/21 on 29.12.2022.

The Two letters being letters being nos.12947/AB-I dated 16.12.2022 and 14044/AB-I dated 16.12.2022 regarding production of the accused in Bangalore and the petition filed today by the NIA were taken up for consideration.

One Bail application has been filed on behalf of the Accused no.(A-15).
