The Accused nos.(A-7), (A-10), (A-11), (A-12) and (A-13) are not produced from J.C.

Received one report regarding non production of the Accused nos.(A-7), (A-11), (A-12) and (A-13) from the Superintendent of Presidency Correctional Home vide their office letter no.1630/AB dated 02.02.2023.

No report regarding non production of the Accused no.(A-10) has yet been submitted by the concerned Correctional Home.

The Accused nos.(A-8) and (A-20) are on Court Bail and are present in Court by filing hazira.

One fresh Vakalatnama has been filed on behalf of the Accused no.(A-14)

Ld. Advocates of the Accused persons are present in Court.

Ld. Special P.Ps. are also present.

No witness is present today.

Received one report from the Law Section, DD, Kolkata which is duly forwarded by the O/C, Law Section, DD, Kolkata stating that witness namely K. Majumder is unable to attend Court today due to her illness and prayed for another date.

One petition has been filed on behalf of the prosecution praying for an adjournment on the ground stated therein.

Heard both sides. Prayer is considered and allowed.

The Superintendent of Presidency Correctional Home, Alipore is directed to produce of the Accused person nos.(A-7), (A-11), (A-12) and (A-13) before this Court on the next date fixed i.e.06.03.2023.

The Superintendent of Dum Dum Central Correctional Home, Alipore is directed to take necessary steps for production of the Accused person no.(A-10) and also directed to submit a report as to why the Accused person no.(A-10) is neither produced, nor any report regarding non production of the Accused is submitted before this Court on the next date fixed i.e.06.03.2023.

Fix **06.03.2023** for Evidence of C.S.W.-4 and hearing of the Bail application dated 19.12.2022 filed by the Accused no.(A-4).

Issue summons at once.

Requisites at once.

The Accused person nos.(A-2), (A-3), (A-4), (A-14) and (A-15) are remanded to J.C. till 06.03.2023.

To-date i.e.06.03.2023 for production of the Accused nos.(A-7), (A-10), (A-11), (A-12) and (A-13) from J.C.

The Accused person nos.(A-8) and (A-20) as before.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home, Alipore for information and necessary action.
