Advocate on behalf of the Accused No.**(A-15), Manirul Islam @ Doctor** prays for releasing the Accused/petitioner on bail in view of order of the Hon'ble High Court, Calcutta.

Perused the certified copy of order dated 20.03.2023 passed by the Hon'ble High Court, Calcutta in connection with C.R.M. (DB) 667 of 2023 wherein the Hon'ble High Court, Calcutta has been pleased to pass an order to that effect that:

“Accordingly, the petitioner be released on bail upon furnishing a bond of Rs.25,000/- with two sureties of like amount each, one of whom must be local to the satisfaction of the learned Chief Judge, City Sessions Court, Calcutta on condition that the petitioner shall appear before the trial court on every date of hearing and shall not intimidate witnesses or tamper with evidence in any manner whatsoever and on further condition that the petitioner while on bail shall remain within the municipal limits of the city of Kolkata and shall provide the address where he shall presently reside to the Investigating Agency as well as the court below and shall report to the Officer-in-charge of the police station within whose jurisdiction he shall presently reside once in a week until further orders.

In the event he fails to appear before the trial Court without any justifiable cause, the trial court shall be at liberty to cancel his bail automatically without reference to this Court.

The application being C.R.M. (DB) 667 of 2023 is disposed of.”

In view of the order dated 20.03.2023 passed by the Hon'ble High Court, Calcutta in connection with C.R.M. (DB) 667 of 2023, the Accused No.**(A-15), Manirul Islam @ Doctor** be released on bail upon furnishing a bond of Rs.25,000/- **(Rupees Twenty five thousand only), with two sureties of like amount each, one of whom must be local** to the satisfaction of this Court on condition that he shall strictly comply with above mentioned the order of the Hon'ble High Court, Calcutta.

Put up the case record as and when bail bond is furnished.
