Heard Ld. Advocate for the accused/petitioner.

The Superintendent of Presidency Correctional Home, Alipore is directed to provide proper medical diet to the accused/petitioner namely Ahammad Ali @ Kalu as per prescription of the Medical officer within the ambit of Jail Code and submit a report to that effect by the next date fixed.

The (08) Accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 08.08.2023.
